WHEREAS, the recognition was granted to the institution namely Sai Teja College of Education, Jangaon Revenue Division, C/o. Vyasa Gurukula School, Kallam Road, Jangaon, Warangal-505223 Telangana run by Sai Educational Society, C/o Sai Teja Junior College, Opp T.V. Studio, Ramanathpur, Hyderabad-13 Telangana vide SRC (NCTE) order F.AP/NEW/B.Ed/182/SRO/NCTE/2003-2004/563 dt. 30.02.2003 (P-674/Coors.) for conducting B.Ed. course of one-year duration with an annual intake of 120 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 09.02.2015 for its willingness for adherence of provisions of new Regulations. A provisional revised recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the FDRs in original were returned to the institution vide letter dt.01.07.2015. The SRC in its 315th meeting held on 17th -18th June, 2016 considered the matter decided to issue a letter. Accordingly, as per decision of SRC a letter was issued to the institution on 03.08.2016.

AND WHEREAS, the SRC in its 377th meeting held on 03rd-04th July, 2019 and the Committee decided that Final Show Cause Notice. Accordingly, as per the decision of SRC a Final show cause notice was issued to the institution on 17.07.2019. The institution did not reply to the final show cause notice.

"It is also pertinent to mention here that the Registrar, Kakatiya University, Warangal, Telangana vide letter No. 1208/CDC/KU/2015 dated 28.08.2019, has informed that the University has discontinued the extension of affiliation from the academic year 2016-17 in respect of the institution Sai Teja College of Education, Jangaon Revenue Division, C/o. Vyasa Gurukula School, Kallam Road, Jangaon, Warangal-505223 Telangana."

AND WHEREAS, the SRC in its 383rd meeting held on 07th to 09th January, 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in (i) response to Show Cause Notice (SCN) issued to the Institution on 03.08.2016. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 17.07.2019. The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN).

(ii) The Registrar, Kakatiya University, Warangal, Telangana vide letter No. 1208/CDC/KU/2015 dated 28.08.2019, has informed that the University has discontinued the extension of affiliation from the academic year 2016-17 in respect of the institution Sai Teja College of Education, Jangaon Revenue Division, C/o. Vyasa Gurukula School, Kallam Road, Jangaon, Warangal-505223 Telangana.

Hence, the Committee decided to withdraw the recognition granted to Sai Teja College of Education, Jangaon Revenue Division, C/o. Vyasa Gurukula School, Kallam Road, Jangaon, Warangal-505223 Telangana for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sai Teja College of Education, Jangaon Revenue Division, C/o. Vyasa Gurukula School, Kallam Road, Jangaon, Warangal-505223 Telangana run by Sai Educational Society, C/o Sai Teja Junior College, Opp T.V. Studio, Ramanathpur, Hyderabad-13 Telangana for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
