WHEREAS, recognition was granted to the institution namely Islamia College of Education. Siddipet-502103, Medak District, Andhra Pradesh run by Islamia Education Society, Siddipet. Medak. Telangana vide SRC (NCTE) F.AP/B.Ed/NEW/39/SRO/NCTE/2000-2001/1225 dt. 17.07.2000 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2000-2001.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the institution has submitted its written representation on 20.07.2015 along with some relevant documents. The SRC in its 315th meeting held during 17th & 18th June, 2016 considered the matter and decided as under:

- 1. Title deed is there. EC is in order.
- 2. Only Rs. 40,000 has been paid. Balance of Rs.1,10,000 may be collected.
- 3. BP is in order. According to BP, built up area is adequate.
- 4. BCC, LUC, original FDRs and, latest Faculty list are not there.
- 5. Collect balance of fee & Cause inspection for shifting B.Ed (2 units).

AND WHEREAS, as per the decision of SRC a letter dated 12.07.2016 sent to the institution. The institution did not reply to the letter till date. The SRC in its 381st meeting held on 31st Oct & 01st Nov, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were

The SRC in its 315th meeting held during 17th & 18th June, 2016 considered the matter and decided as under:

- 1. Title deed is there. EC is in order.
- 2. Only Rs. 40,000 has been paid. Balance of Rs.1,10,000 may be collected.
- 3. BP is in order. According to BP, built up area is adequate.

5. Collect balance of fee & Cause inspection for shifting B.Ed (2 units).

Accordingly, as per the decision of SRC a letter dated 12.07.2016 sent to the institution. The institution did not reply to the letter till date.

Hence, the Committee decided to withdraw the recognition granted to Islamia College of Education, Siddipet-502103, Medak District, Telangana for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Islamia College of Education, Siddipet-502103, Medak District, Telangana run by Islamia Education Society, Siddipet, Medak, Telangana for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
