WHEREAS, the recognition was granted to the institution namely B.S & J.R. College of Education, Srikakulam DT, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/ B.Ed/285/SRO/NCTE/2002-2003/7137 dt 05.05.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 31.12.2014 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 28.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 21.02.2019. The institution vide letter dated 20.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. As per the decision of SRC a final show cause notice was issued to the institution on 08.11.2019. The institution vide letter dated 26.11.2019 received on 03.12.2019 submitted reply to the final show cause notice.

AND WHEREAS, the SRC in its 387th Meeting held on 24th - 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993. Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 03.12.2019. The Committee observed and found the following deficiencies: -

- 1. The institution has not submitted certified copy of registered land.
- 2. Diverted area is not mentioned in the certificate submitted as a CLU.
- 3. Multipurpose Hall is not mentioned in BCC.

- 4. Photocopy of staff list approved by the Principal, BS & JR College of education, Tekkali countersigned by Registrar, Dr. B.R. Ambedkar University consisting of 8 assistant professors submitted dated NIL for the academic session 2018-2019.
 - a. The institution has also submitted photocopy of staff list for D.Ed course dated 18.08.2012 approved by Director, SCERT, A.P.
 - b. Lecturer at S.No. 9 & 10 was appointed on 30.10.2019, thus not having NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
- 5. The institution has not submitted Form 'A' issued by the Branch Manager in favour of NCTE. The photocopy of FDR submitted has been expired.

Hence, the Committee decided to withdraw the recognition granted to B.S. & J.R College of Education, Tekklali Revenue Division, Akkavaram Village, Tekkali, Srikakulam District-532202, Andhra Pradesh for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of B.S. & J.R College of Education, Tekklali Revenue Division, Akkavaram Village, Tekkali, Srikakulam District-532202, Andhra Pradesh for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
