WHEREAS, the recognition was granted to the institution namely B.S.N Memorial College of Education, 1033, Kumaraveedi, Kottavalsa, Vizianagaram Dist-535183, Andhra Pradesh run by Pedro Educational Welfare Society, Plot No. 302, Latha Hospital Road, Waltair Up Lands Village, Andhra University Post, Visakhapatnam Urban Taluk, Visakhapatnam City District-530003, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/273/SRO/NCTE/2002-2003/7773 dt. 26.06.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, the Institution submitted shifting proposal on 12.09.2007. A letter to the institution was sent on 03.06.2009 regarding submission of documents for shifting. The SRC in its 254<sup>th</sup> meeting held on 25-27<sup>th</sup> of October, 2013 considered the matter and decided as under:

"Cause Inspection, Obtain the missing documents, examine and put up by 31st December, 2013."

**AND WHEREAS**, a letter to the institution was sent on 04.02.2014 conveying the decision of SRC. The Institution submitted documents on 24.02.2014 informing that same building was purchased where recognition was given. The documents were processed & placed before SRC in its 264<sup>th</sup> meeting held on 1<sup>st</sup> - 3<sup>rd</sup>March, 2014. The Committee considered the matter & decided as under:

 Issue Show Cause Notice for inadequate land area and inadequate area of multipurpose hall.

**AND WHEREAS**, as per decision of SRC a show cause notice was issued on 06.04.2015. On 31.12.2014, letters were issued to all existing institutions regarding notification of new Regulations, 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

**AND WHEREAS,** on 06.01.2015, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students.

AND WHEREAS, the SRC in its 276<sup>th</sup> meeting held on 7<sup>th</sup>-9<sup>th</sup>January, 2015 decided to issue provisional recognition orders to the existing institutions and the committee also decided to maintain a check list of such cases for verification in October/November and for causing inspection. Before issuance of Show Cause Notice, as per website information, the institution submitted reply on 06.04.2015.

AND WHEREAS, as per Regulations, revised recognition order was issued to the institution on 30.05.2015 with an annual intake of 100 students, with a condition that reply to the SCN dated
