WHEREAS, the recognition was granted to the institution namely Pragathi College of Education, Rangareddy DT, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/284/SRO/NCTE/2002-2003/6688 dt 8.4.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the institution has submitted shifting proposal along with DD of Rs.40,000/-bearing No.543049 dated 25.08.2007 on 10.09.2007. Accordingly, a letter was sent to the institution on 26.05.2009 regarding submission of all documents for shifting. The institution has submitted its written representation on 17.06.2009 along with some relevant documents for shifting the institution in permanent location.

AND WHEREAS, on 31.12.2014 letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, the institution has submitted its written representation on 30.07.2015 along with shifting fee of Rs. 1,10,000/- DD No. 274569 dated 29.07.2015 and relevant documents. The institution has submitted its written representation on 06.08.2015 regarding the institution already shifted to permanent premises- update of address and change of name of society to Kommuri Pratap Reddy Educational Society. The institution has submitted its written representation on 31.10.2015 along with some relevant documents.

AND WHEREAS, the documents were processed and placed before SRC In its 315th meeting held on 17th -18th June, 2016. The Committee considered the matter and decided constitute to VT. As per the decision of SRC inspection intimation was sent to the institution on 12.07.2016 and VT members through online mode. The Inspection of the institution was conducted on 06th & 07th November 2016 and VT report along with documents and CD received on 09.11.2016.

AND WHEREAS, the SRC in its 339th meeting held on 22nd & 23rd May 2017 considered the VT report and decided to issue show cause notice. Accordingly, as per decision of SRC show cause notice was sent to the institution on 30.05.2017.

AND WHEREAS, the institution submitted reply along with documents on 28.06.2017. The SRC in its 344th meeting held on 17th & 18th August 2017 considered the matter and decided as under;

- 1. The issue relating to change of Management has been satisfactorily explained. It is a case of only a change in the name of the Management and not the Management itself. We accept this explanation.
- 2. They have shifted without permission. We have to consider this.
- 3. Process the documents collected and report.

AND WHEREAS, the SRC in its 346th meeting held on 24th & 25th October 2017 considered the matter and decided as under: -

- 1. The title position is very confusing.
- 2. Seek Clarifications from them. Process, and put up in the next meeting.

AND WHEREAS, as per the decision of SRC, a letter was sent to the intuition on 02.11.2017. The SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, a Final Show Cause Notice was issued on 19.11.2019. The institutions vide letter dated 05.12.2019 submitted reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 387th Meeting held on 24th – 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 05.12.2019. The Committee observed and found the following deficiencies: -

- 1. The institution has not submitted certified copy of land documents. The land document is in the name of an individual.
- 2. Total land area mentioned in the land document. CLU and NEC are 6 acres 8 guntas, 12 acres, 707 guntas respectively.
- 3. Building plan is not approved by the competent authority. Site area is not mentioned, and multipurpose hall area is not readable.
- 4. Site plan is not approved by the competent authority. Site area is not mentioned.
- 5. Photocopy of staff list approved by the Chairman, Pragathi College of Education consisting of one principal, 15 assistant professors submitted dated 18.04.2019.
 - a) The staff list submitted by the institution is not in the prescribed NCTE Format.
 - b) Staff list is not approved by the affiliating body.

Hence, the Committee decided to withdraw the recognition granted to Pagathi College of Education, Hyderabad East Revenue Division, 1-53, Peerzadiguda Village, Ghatkesar Mandal, Rangareddy District, Andhra Pradesh for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Pragathi College of Education**, **Rangareddy District, Telangana** for conducting **B.Ed**. programme of two year duration with an annual intake of **100** students (2 units) w.e.f. the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
