WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely Educare College of Education, Jagaon Revenue Division, Sree Ram Nagar, Opp AP Dairy Farm, Jangaon, Warangal District, Telangana run by Vignana Bharati Educational Society, H.No. 6-2-44/7/1, KankarRaod, Mahabubnagar-506101, Warangal District, Telangana vide SRC (NCTE) order no. F.AP/NEW/B.Ed//146/SRO/NCTE/2002-2003/6659 dt 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter provisional revised recognition order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, on the basis of request, the SRC in its 342nd Meeting decided for reduction of intake from 2 Units to 1 Unit. Accordingly a order vide order no. F.No.SRO/NCTE/APSO0367/B.Ed/TS/2017-18/94040 dt. 21.07.2017 was issued to the institution.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 28.02.2019. The institution did not reply to Show Cause Notice till date.

AND WHEREAS, the SRC in its 377th meeting held during 03rd – 04th July, 2019 considered the matter and decided to issue a Show Cause Notice. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 17.07.2019. The institution did not reply to Final Show Cause Notice till date.

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

- (i) The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 28.02.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 17.07.2019. Even after giving opportunity through FSCN, the Management of the Institution failed to submit the required documents/information sought in SCN & FSCN.
- (ii) A letter vide no. 1208/CDC/KU/2019 dated 26.08.2019 sent by the Registrar, Kakatiya University has been received in this office of SRC stating therein that the Institution is not affiliated with the University w.e.f. 2016-17 session

Hence, the Committee decided to **withdraw the recognition** granted to **Educare College of Education, Jagaon Revenue Division, Sree Ram Nagar, Opp AP Dairy Farm, Jangaon, Warangal District, Telangana** for conducting **B.Ed.** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above and close the file.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
