WHEREAS, recognition was granted to the institution namely Leyas College of Education, Flat No. 302, Sai Arcade, 6th Phase, Plot No. 527 & 528, VIthPhase KPHB Colony, Kukataplly, Hyderabad-500072, Andhra Pradesh run by Holy Trinity Educational Society, Flat No. 302, Sai Arcade, 6th Phase, Plot No. 527 & 528, VIth Phase KPHB Colony, Kukataplly, Hyderabad- 500072, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/199/SRO/NCTE/2002-2003/6673 dt. 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2002-2003.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 22.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 13.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 363rd meeting held on 17th -19th September, 2018 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 12.10.2018. The institution did not reply to the show cause notice.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380th meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the Institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 14.10.2019. The institution did not reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 12.10.2018. (i) Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 14.10.2019. The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN).

Hence, the Committee decided to withdraw the recognition granted to Leyas College of Education, Flat No. 302, Sai Arcade, 6th Phase, Plot No. 527 & 528, VIth Phase KPHB Colony, Kukatapily, Hyderabad-500072, Telangana for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.
