WHEREAS, the recognition was granted to the institution namely Talla Padmavathi College of Education, Warangal District, Andhra Pradesh run by Learners and Scholars Educational Society, URUS (V), GramaPanchayathiThimmapur Haveli, Hanamkonda Mandal, Warangal District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/204/SRO/NCTE/2002-2003/6713 dt. 04.04.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt.21.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 26.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC vide order no. F.SRO/NCTE/APSO0380/B.Ed/TS/2016-17/89150 dated 22.10.2016 was issued to the institution for shifting of premises to new location at **H.No**. **7-45/5**, **Urus**, **Kareemabad**, **Warangal-506002**, **Telangana**.

AND WHEREAS, a letter vide no. 1208/CDC/KU/2019 dated 26.08.2019 sent by the Registrar, Kakatiya University has been received in this office of SRC stating therein that the institution Talla Padmavathi College of Education, Warangal District, Telangana.

AND WHEREAS, the SRC in its 384th Meeting held on 12th - 13th February, 2020 considered the matter and decided as under:-

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:

(i) A letter vide no. 1208/CDC/KU/2019 dated 26.08.2019 sent by the Registrar, Kakatiya University has been received in this office of SRC stating therein that the Institution is not affiliated with the University w.e.f. 2019-20 session.

Hence, the Committee decided to withdraw the recognition granted to Talla Padmavathi College of Education, Warangal Dt, Telangana for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above and close the file.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Talla Padmavathi College of

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order.
