WHEREAS, recognition was granted to the institution namely Akula Gopaya College of Education, Prathipadu, Tadepalligudem-5341101, West Godavari District, Andhra Pradesh run by Sri Gowthama Buddha Minorities Educational Society, Pydiparru, Tanuku-534211, West Godavari District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.Ed/294/SRO/NCTE/2003-2004/9568 dt. 10.09.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the SRC in its 211th meeting held on 21st - 23rd September, 2011 decided to of the institution. Accordingly withdrawal withdraw the recognition F.No.APSO0706/B.Ed/AP/2011-12/32287 dated 15.11.2011 was issued to the institution.

AND WHEREAS, the SRC in its 221st meeting held on 19th - 20thApril, 2012 considered the restore and decided to 20.03.2012 appellate authority order dt. no.F.No.APSO0706/B.Ed/AP/2012-13/41663 dated 18.05.2012 was issued to the institution.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 29.01.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition Order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 19.02.2019. The institution did not reply to the show cause notice till date.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 11.10.2019. The institution did not reply to Final Show Cause Notice till date. The SRC in its 382nd meeting held on 26th - 27th November, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following deficiency/observations were made:-

The institution was issued Final Show Cause Notice on 11.10.2019. But the institution has not yet submitted its reply till date.

Hence, the Committee decided to withdraw the recognitions granted to Akula Gopaya College of Education, Prathipadu, Tadepalligudem-5341101, West Godavari District, Andhra Pradesh for conducting B.Ed courses w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Akula Gopaya College of Education, Prathipadu, Tadepalligudem, West Godavari District-534101, Andhra Pradesh run by Sri Gowthama Buddha Minorities Educational Society, Pydiparru, Tanuku-534211, West Godavari District, Andhra Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
