WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **Anjanadevi B.Ed. College, C/o S.H.Patil ITI College, Shed C-7, Industrial Area, Near Water Tank, Banjari Kallur Road, Humnabad-585330, Bidar District, Karnataka** run by **Chandana OBC Educational and Charitable Trust, Humnabad Bidar District, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/APS01792/2004-2005/9090 dt 2.12.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 16.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, the institution submitted written representation on **17.06.2015** requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. The SRC issued a Corrigendum vide Order No.F.SRO/NCTE /APS01792/B.Ed/KA/2015-2016/69057 dated 01.07.2015 to the institution reduce intake of 2 units to 1 unit.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, a Show Cause Notice issued on **26.02.2019**. The institutions vide letter dated 29.11.2019 submitted reply to the Show Cause Notice.

AND WHEREAS, the SRC in its 377th meeting held during 03th & 04th July, 2019 considered the written representation and decided to issue final show cause notice. Accordingly as per the decision of SRC a Final SCN issued to the institution on 15.07.2019. The institution submitted application for shifting of premises vide letter dated 05.09.2019 and DD also submitted of Rs 150000.00/-.

AND WHEREAS, the SRC in its 387th meeting held on 24th – 25th August, 2020 considered the matter and decided as under -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 05.09.2019. The Committee observed and found the following deficiencies: ..

1. *The institution has submitted photocopy of land document but certified copy document not submitted.*
2. *The institution has submitted Non-Encumbrance Certificate which is in regional language. Notarised English translated version of the same has not been submitted by the institution.*
3. *The institution has submitted copy building plan but not approved by competent authority.*
4. *The institution has submitted copy site plan but not approved by competent authority.*
5. *The institution has submitted copy of building completion certificate but built up area not mentioned.*
6. *The institution has not submitted copy of staff list duly approved by the Registrar, affiliating university.*

Hence, the Committee decided to **withdraw the recognition** granted to **Anjanadevi B.Ed College, C/o S.H.Patil ITI College, Shed C-7, Industrial Area, Banjaru Kallur Road, Bidar-585330, Karnataka** for conducting **B.Ed. course** w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Anjanadevi B.Ed. College, C/o S.H.Patil ITI College, Shed C-7, Industrial Area, Near Water Tank, Banjari Kallur Road, Humnabad-585330, Bidar District, Karnataka** run by **Chandana OBC Educational and Charitable Trust, Humnabad Bidar District, Karnataka** for conducting **B.Ed. programme** of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website

www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
