WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **Sri Fulsing Narayan Chavan Memorial College of Education, Hittinahalli, Sindgi Taluk, Bijapur Dist- 586215, Karnataka** run by **Shri Jagadamba Vidya Vardhak Sangh, Tamba, Dist- Bijapur, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/APS01969/2004-2005/8895 dt 30.11.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, the institution has submitted a written representation on 03.08.2015. The SRC in its 315th meeting held during 17th& 18th June, 2016 considered the matter and decided as under:

1. They have contested the shifting condition saying that they have all along been in their premises.
2. Ask them to show again title to the lands buildings.
3. Collect fee and cause inspection.
4. Ask VT to collect all relevant documents; collect the latest approved Faculty List; and, check in particular adequacy of built up area for B.Ed (2 units).

AND WHEREAS, a letter was sent to the institution on 12.07.2016. The SRC in its 343rd meeting held during 1st to 2nd August, 2017 considered the matter and decided as under;

1. These are RPRO cases. In view of the latest instructions, no inspection is required in these.
2. But, these also involve 'shifting'. Therefore, VT inspection will be required.
3. The SRO's request is noted and permission is given for organizing VT inspection in these cases.

AND WHEREAS, the Sub-Committee Constituted by the SRC in its meeting held on 22nd Oct., 2019. The sub-committee noted that institutions have not submitted requisite documents or only part reply has been submitted. Accordingly, as per the decision of First SRC a show cause notice was issued to the institution on 30.09.2019. The institution has submitted reply dated 13.11.2019 to the First SCN.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the

following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly Final Show Cause Notice was issued on 20.12.2019. The institutions vide letter dated 03.01.2020 submitted reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 384th meeting held on 12th -13th February, 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 13.11.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 20.12.2019. The institution vide letter dated 03.01.2020 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under: -

1. The institution is required to submit certified copy of registered land duly approved by the competent govt. authority.
2. The size of Multipurpose Hall is not reflecting in the Building plan. The total built up area mentioned in building plan is insufficient as per NCTE Norms.
3. The BCC submitted by the institution where total built up area is not adequate as per NCTE norms.
4. The institution has not submitted a copy of approved site plan.
5. The institution submitted a list of Faculty members (1+14) which is not in the standard format of NCTE
6. The institution submitted Original FDRs of Rs.7,15,257/- with maturity date 05.02.2018 & Rs.7,26,391/- with maturity date 30.07.2018

Hence, the Committee decided to **withdraw the recognition** granted to **Sri Fulsing Narayan Chavan Memorial College of Education, Hillinahalli, Sindgi Taluk, Bijapur District-586215, Karnataka** for conducting **B.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Sri Fulsing Narayan Chavan Memorial College of Education, Hittinahalli, Sindgi Taluk, Bijapur Dist- 586215, Karnataka** run by **Shri Jagadamba Vidya Vardhak Sangh, Tamba, Dist- Bijapur, Karnataka** for conducting **B.Ed.** programme of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
