**WITHDRAWAL ORDER**

**WHEREAS**, recognition was granted to the institution namely **Reva Institute of Education, 48A, Lakshmaiah Block, 11<sup>th</sup> Cross, CBI Road Ganganagar, Bangalore-560024, Karnataka** run by **Bheemane's Educational System Trust, Bangalore, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/2004-2005/8931 dt. 30.11.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2004-2005.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 24.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, thereafter, provisional revised recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

**AND WHEREAS**, a corrigendum vide order no F.SRO/NCTE/APSO2131/B.Ed/KA/2015-16/67239 dated: 16.06.2015 was issued to the institution.

**AND WHEREAS**, the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 26.04.2019. The institution did not submit reply to the SCN.

**AND WHEREAS**, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken at its 380<sup>th</sup> meeting. The Sub-Committee of the SRC decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a Final show cause notice was issued to the institution on 15.10.2019. The institution vide letter dated 26.10.2019 submitted a written representation for **closure of B.Ed Programme**.

**AND WHEREAS**, the SRC in its 383<sup>rd</sup> meeting held on 07<sup>th</sup> to 09<sup>th</sup> January, 2020 considered the matter and decided as under:-

The Committee decided that to withdraw the recognition granted to **Reva Institute of Education, 48A, Lakshmaiah Block, 11<sup>th</sup> Cross, CBI Road Ganganagar, Bangalore-560024, Karnataka** for conducting B.Ed course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 28.12.2019. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

**"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."**

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
