WHEREAS, the -recognition was granted to the institution namely Moulana Azad B.Ed College, Radhakrishna Nagar, Teachers Layout, Mysore-5700011, Karnataka run by Sultan Education Tust, 59, III Coss, Vii Main, Sarawathipuram, Mysore-570009, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2004-2005/5902 dt. 30.11.2004 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 29.05.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, a corrigendum order no. F.SRO/NCTE/APSO2430/B.ED/KA/2015/76975 dated 27.10.2015 issued to the institution for one basic unit.

AND WHEREAS, the SRC in its 375th meeting decided to issue common SCN to all such institutions (one unit or two or more unit cases) asking to submit details regarding additional facilities, additional infrastructure, additional fund, additional staff as per Regulation, 2014.

AND WHEREAS, accordingly, as per the decision of SRC a show cause notice was issued to the institution on 24.04.2019. The institution vide letter dated 06.05.2019 submitted its reply to the show cause notice along with the documents.

AND WHEREAS, the SRC in its 380th meeting held during 18th – 19thSeptember, 2019 considered the matter and decided to issue Final Show Cause Notice to the institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 09.10.2019. The institution vide letter dated 04.11.2019 submitted its reply to the Final Show Cause Notice. The SRC in its 382nd meeting held on 26th – 27th November, 2019 considered the matter and decided to issue a letter. Accordingly, as per the decision of SRC a letter was issued to the institution on 10.12.2019. The institution vide letter dated 06.01.2020 its reply to the letter. The SRC in its 384th meeting held on 12th -13th February, 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 24.04.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 09.10.2019. The institution vide letter dated 04.11.2020 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

1. The institution has not submitted LUC duly approved by the competent authority.

- 2. The institution submitted notarized copy of building plan in the name of Sultan Shaheed Education Trust approving authority stamp and signature is not readable
- 3. The institution has not submitted BCC duly approved by the competent authority.
- 4. The institution submitted a list of 6 faculty members which is not approved by the competent authority.

Hence, the Committee decided to withdraw the recognition granted to Moulana Azad B.Ed College, Radhakrishna Nagar, Teachers Layout, Mysore-5700011, Karnataka for conducting **B.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Moulana Azad B.Ed College, Radhakrishna Nagar, Teachers Layout, Mysore-5700011, Karnataka run by Sultan Education Tust, 59, III Coss, Vii Main, Sarawathipuram, Mysore-570009, Karnataka for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
