WHEREAS, the recognition was granted to the institution namely Sanjay Gandhi College of Education, Chola Nagar, Hebbal, Bangalore - 560032, Karnataka vide SRC (NCTE) order no. F KAR/B Ed/065/SRO/NCTE/2000-2001/989 dt 11 07.2000 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 27 01 2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.05.2015 for conducting B Ed course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015 16

AND WHEREAS, the institution submitted written representation on 29.06.2015 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. The SRC issued a Corrigendum vide Order No.F SRO/NCTF/APS03352/B.Ed/KA/2015/68797 dated 30.06.2015 to the institution reduce intake of 2 units to 1 unit.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 13.03.2019. The institutions vide letter dated 21.03.2019 submitted reply to the Show Cause Notice.

AND WHEREAS, the SRC in its 378<sup>th</sup> meeting held on 25<sup>th</sup> – 26<sup>th</sup> July, 2019 considered the matter decided to issue final show cause notice. As per the decision of SRC a Final Show Cause Notice was issued to the institution on 30 07 2019. The institution vide letter dated 16.08.2019 & 25.02.2019 submitted reply to the Final Show Cause Notice.

**AND WHEREAS,** the SRC in its 387<sup>th</sup> meeting held on 24<sup>th</sup> = 25<sup>th</sup> August, 2020 considered the matter and decided as under

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made.

On the perusal of the reply submitted by the institution on 16.08.2019 & 25.02.2019. The Committee observed and found the following deficiencies:

1 At the time of recognition, the name of the management was "Jawahar Bharathi Educational Trust, Vasanthanagar, Bangalore-560052" and the now as per

- (ii) The institution has submitted staff list one principal Four Assistant Professor, Three Lecturer against the requirement for B.Ed. one basic unit 1+8 full time staff

Hence the Committee decided to withdraw the recognition granted to Sanjav Gandhi College of Education, Chola Nagar, Hebbal, Bangalore-560032 fc conducting B.Ed. course wielf the 2020 21 academic session under clause 17(1) of NCTF Act, 1993 on the grounds mentioned above

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Sanjay Gandhi College of Education, Chola Nagar, Hebbal, Bangalore 560032, Karnataka for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or aft undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further if the institution is not satisfied with the Order it may prefer an Appeal under Section 18 of the NCTI Act. 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
