WITHDRAWAL ORDER**

WHEREAS, Recognition was granted to the institution namely A.M.G. College of Education, G.T. Road, Chilakaluripet, Guntur, Andhra Pradesh run by Advancing the Ministries of Gospel of India International, G.T. Road, Chilakaluripet, Guntur, Andhra Pradesh vide SRC (NCTE) order no. F.No.42-148/2001 Appeal/16822 dt. 07.02.2002 for conducting B.Ed. course of one-year duration with an annual intake of 60 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 27.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO.

AND WHEREAS, as per the decision of SRC a show cause notice was issued to the institution on 06.03.2019. The institution vide letter dated 20.03.2019 submitted reply to the show cause notice.

AND WHEREAS, the SRC in its 378th meeting held on 25th – 26th July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the original documents and records made available in the file. The Committee decided that to **withdraw the recognition** granted to A.M.G. College of Education, G.T. Road, Chilakaluripet, Guntur, Andhra Pradesh for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- NOC from the affiliating body.
- NOC from the staff/faculty.
- Resolution of the management to the effect for closure of the course

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **A.M.G. College of Education, G.T. Road, Chilakaluripet, Guntur, Andhra Pradesh** run by **Advancing the Ministries of Gospel of India International, G.T. Road, Chilakaluripet, Guntur, Andhra Pradesh** for conducting B.Ed programme of two years duration with an annual intake of 100 students (2 units) on the grounds mentioned above.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
