WITHDRAWAL ORDER

2 6 SEP 2019

WHEREAS, Recognition was granted to the institution namely U.S.P. College of Education, Kodikurichi - Tenkasi Road, Kodikurichi Village, Tenkasi Taluk, Tirunelveli, Tamilnadu vide SRC, NCTE's order dt. 13.07.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 seats.

AND WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the NCTE Act, 1993 (73 of 1993) the NCTE (Recognition Norms and Procedure), Regulations, 2014 were notified on 01.12.2014 in supersession of the NCTE (Recognition Norms and Procedure), Regulations, 2009.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the duration of the B.Ed. course was increased from one year to two years and the existing institutions offering B.Ed. course, of one-year duration, were required to give their acceptance, in the form of an affidavit, for adherence of the NCTE Regulations, 2014.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted an affidavit dt. 19.01.2015 (P-245/Coors.) for its willingness and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 12.05.2015 (P-247/Coors.) for conducting B.Ed. course of two years' duration with an annual intake of 100 students (2 units) from the academic session 2015-2016.

AND WHEREAS, the matter of the institution was considered by the SRC in its 315th meeting held on 17th -18th June 2016 wherein the SRC decided to conduct the inspection. Therefore, the inspection of the institution was conducted on dt. 22.08.2016.

AND WHEREAS, the matter was again considered by the SRC in its 377th meeting held on 3rd & 4th July 2019 and decided to issue Final Show Cause Notice u/s 17 of NCTE Act, 1993.

AND WHEREAS, accordingly, the Final Show Cause Notice was issued on 16.07.2019 and in compliance the institution has submitted its reply (received on 02.08.2019).

AND WHEREAS, the SRC in its 380th meeting held on 18th & 19th September 2019 considered the matter and decided as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

- (i) The building plan submitted by the Institution at the time of recognition was of U. S. P School building and on the same it was overwritten as USP B.Ed. College which is a fraud. Actually, the building plan is approved for UPS School. The same is erased and written as USP B.Ed. College. As the document is fabricated a such it is fraud committed by the institution.
- (ii) The land documents submitted by the institution is in favour of Mr. Selvaraju (Individual), therefore the same is not as per NCTE norms.
- (iii) The faculty namely Mr. V. Murugan, Mr. R. Murugesan and Miss M. Vanitha does not possess the qualifications laid down in the NCTE Regulations, 2014.

Hence, the Committee decided to withdraw the recognition granted to U.S.P. College of Education, Kodikurichi-Tenkasi Road, Kodikurichi Village, Tenkasi Taluk, Tirunelveli, Tamil Nadu for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of U.S.P. College of Education, Kodikurichi - Tenkasi Road, Kodikurichi Village, Tenkasi Taluk, Tirunelveli, Tamilnadu granted SRC vide order no. F.SRO/NCTE/B.Ed/2006-2007/6506 dt. 13.07.2007 for conducting B.Ed. course of one year' duration with an annual intake of 100 students from the next academic session starts after issuance of this order. The provisional revised recognition orders No. F.SRO/NCTE/APSO3584/B.Ed./TN/2014-15/64464 dt. 12.05.2015 issued to the institution in respect of B.Ed course of 2 years duration with an annual intake of 100 seats is also hereby withdrawn.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website http://ncte.gov.in, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
