Withdrawal Order

Whereas, the recognition was granted to the institution namely Star College of Education, Periyamanali, Tiruchengode, Namakkal, Tamilnadu – 637410 run by Star Educational & Charitable Trust 1-84-C, Truchengode Taluk, Periyamanali, Namakkal District-637410, Tamilnadu was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/12737/ 12737 dt. 09.10.2007 for conducting B.Ed. course of two-years duration with an annual intake of 100 students.

And Whereas, the institution has submitted an affidavit dt. 23.01.2015 for its willingness of two units in B.Ed Course for two units to come under NCTE Regulations, 2014.

And Whereas, the revised recognition order was issued to the institution on 05.05.2015 for conducting B.Ed course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

And whereas, the institution requested for reduction of intake from 2 units to 1 unit vide letter dt. 24.10.2016. Accordingly, an order was issued on 04.10.2017 granting reduction of intake from 2 units to 1 unit.

AND WHEREAS, the matter was placed before the SRC in its 380th meeting held on 18th -19th September 2019 wherein the Committee considered the matter and decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 25.09.2019.

Accordingly, a Final Cause Notice was issued on 25.09.2016 The institution has submitted its reply on 13.12.2019.

And Whereas, SRC in its 384th meeting held on 12th & 13th February 2020 and considered the matter as under:

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 03.05.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 25.09.2019. The institution vide letter dated 13.12.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under :-

1. **Land Documents** – The institution has submitted Land Documents in regional language along with the translated notarized version of the same, but the sale deed belongs to an **Agricultural Land**.
2. **Building Plan** – The institution submitted Building Plan which was not approved by the competent authority. The Multipurpose Hall is less than the requirement of NCTE Regulations.
3. **LUC** – The LUC submitted by the institution is not in prescribed format of State Govt. The photocopy of LUC which cannot be accepted on face of deficiency in Land Document
4. **NEC** – The institution has submitted NEC in regional language along with the translated notarized version of the same, but the NEC refers as **“Lease for not below 20 years and not less than 30 years and other property**
5. **BCC** – The institution has submitted photocopy of BCC which suffered with manifold discrepancies of Built Up Area etc. The BCC also not approved by the competent authority.
6. **Faculty** – The institution has not submitted Staff List duly approved by the affiliating university.
7. **Website** – The institution not submitted details of Institution’s Website.

Hence, the Committee decided to withdraw the recognition granted to Star College of Education, Periyamanali, Tiruchengode, Namakkal, Tamilnadu – 637410 for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above. “

Now therefore, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Star College of Education, Periyamanali, Tiruchengode, Namakkal, Tamilnadu – 637410** run by **Star Educational & Charitable Trust 1-84-C, Truchengode Taluk, Periyamanali, Namakkal District-637410, Tamilnadu** from the end of the academic session. The withdrawal recognition is effective for academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
