WHEREAS, the recognition was granted to the institution namely Vegdevi College of Education, Kuvempu Road, Thiruthalli, Shimoga District - 577432, Karnataka run by Sathpatha Education Trust, Shimoga District, Karnataka vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/APS04705/2006-2007/5884 dt 11.12.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 18.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, the institution submitted sbhifting fee of RS. 1,5,000/- vide No. 18971 dated 26.08.2015 for shifting of premises from Kuvempu Road, Thrithahalli Taluk Shivamoga District-577432, to main, Meline, Kuruvalli Post, Thirthahalli Taluk 577432, Shivamoga. The institution also submitted its written representation on 11.01,2016 for one basic unit of 50 students. The SRC in its 315th meeting held during 17th & 18th June, 2016 decided to constitute VT.

AND WHEREAS, as per the decision of SRC a inspection intimation was sent to the institution on 12.07.2016. The manes of VT member were generated through online. The inspection of the institution was conducted on 22.08.2016. VT report along with documents received on 27.08.2016. The matter was placed the SRC in its 339th meeting held on 22th & 23th May, 2017. The committee considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC, a Show Cause Notice was send to the intuition on 30.05.2017. The institution submitted reply to the show cause notice on 23.06.2017.

AND WHEREAS, the SRC in its 381st meeting held on 31st Oct 01st Nov 2019 considered the matter and decided to issued SCN in all such matters where the institution has not submitted the following requisite documents/VT report not accompanied with the requisite documents in response to RPRO issued by the SRC. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 08.11.2019. The institutions vide letter dated 30.12.2019 submitted reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 387th meeting held on 24th - 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on **30.12.2019**. The Committee observed and found the following deficiencies: -

- 1. The institution has not submitted certified copy of registered land.
- 2. The institution has submitted photocopy of building plan but not approved by competent authority the area of multipurpose hall is not adequate as per NCTE norms2014.
- 3. The institution has submitted photocopy of site plan but not approved by competent authority.
- 4. The institution has submitted Photocopy Staff list approved by the Registrar Kuvempu University consisting of one principal and Five Assistant Professor submitted date 26.12.2019.
- (i) Assistant Professor at S.No.4 (Sandesha s) and 5 (Shivakashi hy) do not have NET/Ph.D. as per NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.05.2017 notified on 09.06.2017.
- (ii) The institution has submitted staff list one principal Five Assistant Professor against the requirement for B.Ed. one basic unit 1+8 full time staff
- (iii) The institution has not appointed Performing Arts & Fine Arts faculty.

Hence, the Committee decided to withdraw the recognition granted to Vagdevi College of Education, Kuvempu Road, Thiruthalli, Shimoga Distr-577432, Karnataka for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of Vegdevi College of Education, Kuvempu Road, Thiruthalli, Shimoga District – 577432, Karnataka run by Sathpatha Education Trust, Shimoga District, Karnataka for conducting B.Ed. programme of two year duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government." Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <u>www.ncte-india.org</u> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
