WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely **Global College of Education, Madina Education Centre, No. 5-9-104 to 1604, Opp. Public Garden, P.G. Road, Hyderabad- 500001, Telangana** run by **Madina Educational and Welfare Society, Hyderabad, Telangana** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/6216 Dt. 11.07.2007 for conducting B.Ed. course of one-year with an annual intake 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt.04.02.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov, 2019 decided to issue Show Cause Notice to all such institution where representation has not been submitted by the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 05.11.2019. **The institution did not submit the reply to the Show Cause Notice.**

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

- (i) The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 15.11.2019.
- (ii) *The Registrar, Osmania University, Hyderabad vide letter No. 1554-MR/H/B.Ed/2019-2020/Acad/IV-2 dated 11.12.2019, has informed that the University has discontinued the extension of affiliation from the academic year 2015-2016 in respect of the institution Global College of Education, Madina Education Centre, No. 5-9-104 to 1604, Opp. Public Garden, P.G. Road, Hyderabad- 500001, Telangana.*

Hence, the Committee decided to **withdraw the recognition** granted to **Global College of Education, Madina Education Centre, No. 5-9-104 to 1604, Opp. Public Garden, P.G. Road, Hyderabad- 500001, Telangana** for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
