WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely **Velangini College of Education, J.P.N. Nagar, Miyapur, Hyderabad-500049, Telangana** run by **Holy Trinity Educational Society, Hyderabad, Telangana** vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/11860 dt 25.09.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2006-2007.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 21.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 11.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 315th meeting held on 17th – 18th June, 2016 considered the matter and decided as under;

1. They contest the shifting condition by saying that they have all along been on 'own land'. Their claim is not correct. They were given recognition w.e.f. a 5 years lease deed in 2005. Before 2010, therefore, they should have shifted. Producing a 30 years lease deed in 2010 was not acceptable because by then the 2007 Regulations had done away with leased lands. Their contention is, therefore, rejected.
2. Title deed is therefore not in order.
3. Processing fee not paid. Collect fee.

As per the decision of SRC, a show cause notice was issued to the institution on 12.07.2016. **The institution did not reply to the show cause notice till date.**

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken in its 380th meeting. The Sub-Committee of the SRC decided to issue **Final Show Cause Notice** to all such institution where reply to SCN has not been submitted by the Institution. Accordingly, as per the decision of SRC a Final Show Cause Notice was issued to the institution on 11.10.2019. **The institution did not reply to the Final Show Cause Notice till date.**

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

- (i) The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 12.07.2016. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 11.10.2019. **The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN).**

Hence, the Committee decided to **withdraw the recognition** granted to **Velangini College of Education, J.P.N. Nagar, Miyapur, Hyderabad-500049, Telangana** for conducting **B.Ed. course** w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
