WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the Institution namely **Syed Barey Institute of Education, Barey Hills, Near Adarshnagar, Gulbarga- 585105, Karnataka** run by **Syed Barha Foundation Education Charitable Trust, Gulbarga-585104, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/D.Ed/2006-2007/11060 dt. 03.09.2007 for conducting D.Ed. course of one-year duration with an annual intake of 50 students from the academic session 2007-2008.

AND WHEREAS, the institution submitted a written representation vide letter dated 17.02.2020. The SRC in its 385th meeting held on 03rd March, 2020 considered the matter and decided as under- :

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee decided that to **withdraw the recognition** granted to **Syed Barey Institute of Education, Barey Hills, Near Adarshnagar, Gulbarga- 585105, Karnataka** for conducting **D.Ed course** under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 17.02.2020. However, the FDRs towards Reserve Fund and Endowment Fund/ No Objection Certificate (NOC) for encashment of FDRs will be issued by the Regional Director on the submission of the following:

- (a) NOC from the affilliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Syed Barey Institute of Education, Barey Hills, Near Adarshnagar, Gulbarga- 585105, Karnataka** run by **Syed Barha Foundation Education Charitable Trust, Gulbarga-585104, Karnataka** for conducting **D.Ed. programme** of two year duration with an annual intake of 50 students (1 unit) from the next academic session starts after issuance of this order.

Further, the institution and affilliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails

or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through “online mode” available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
