Withdrawal Order

Whereas, the recognition was granted to the institution namely **Elizabeth College of Education, Selcrist Land, Annamangalam, Perambalur-621102, Tamilnadu** was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/12737/ 12737 dt. 09.10.2007 for conducting **B.Ed. course** of two-years duration with an annual intake of 100 students.

And Whereas, the institution has submitted an affidavit dt. 22.01.2015 for its willingness of two units in B.Ed Course for two units to come under NCTE Regulations, 2014.

And Whereas, the revised recognition order was issued to the institution on 30.04.2015 for conducting B.Ed course of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

And whereas, the institution requested for reduction of intake from 2 units to 1 unit vide letter dt. 24.10.2016. Accordingly, an order was issued on 19.09.2017 granting reduction of intake from 2 units to 1 unit.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 06.08.2019.

AND WHEREAS, the matter was placed before the SRC in its 380th meeting held on 18th -19th September 2019 wherein the Committee considered the matter and decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 31.10.2019.

And Whereas, SRC in its 384th meeting held on 12th & 13th February 2020 and considered the matter as under:

- (i) *The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 06.08.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 31.10.2019. The institution did not submit its reply/representation in response to Final Show Cause Notice (FSCN).*


Hence, the Committee decided to withdraw the recognition granted to Elizabeth College of Education, Selcrist Land, Annamangalam, Perambalur – 621102, Tamilnadu for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Now therefore, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Elizabeth College of Education, Selcrim Land, Annamangalam, Perambalur-621102, Tamilnadu from the end of the academic session. The withdrawal recognition is effective for academic session commences next to issuance of this order.

CSUN 8 5 1 Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

“If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government.”

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through “online mode” available on NCTE’s website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE’s website.
