WHEREAS, the recognition was granted to the institution namely Thorrur College of Education, No. 12-86, Khammam Highways, Thorrur Mandal, Warangal District-506163, Andhra Pradesh run by Vishnu Educational Society, Warangal District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/APS06034/B.Ed/2006-2007/678 dt 12.04.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, the SRC withdrawal vide order no. F.SRO/NCTE/APS06034/Ref/2008-09/5864 dated 06.10.2008 was issued to the institution.

AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. 89-999/2009/-Appeal dated 06.11.2009 appeal confirmation the Order appealed against. As per the SRC a inspection letter was to the institution on 02.09.2010.

AND WHEREAS, the SRC considered the case from time to time in its meetings and finally in its 211th meeting held on 21st – 23rd September 2011 considered the Hon'ble High Court order the reply of the institution dt. 14.09.2011. VT report of the institution and other relevant documents along with the original file of the institution and decided to restore recognition and continue recognition accorded to the institution. Accordingly, the SRC restore the recognition vide order no. F.No.APS06034 /B.Ed/AP/2011-12/31474 dated 28.10.2011 was issued to the institution restored and recognition continues order.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 7.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic unit) from the academic session 2015-16.

AND WHEREAS, the institution has submitted an application dated 05.11.2015 requesting therein for reduction of strength from 2 units to 1 unit in its B.Ed course. The above matter was placed before SRC in its 342nd meeting held on 05th & 06th July, 2017 and the committee decided to reduce the intake from 2 units to 1 unit.

AND WHEREAS, the SRC issued a vide order no. F.No. SRO/NCTE/APS06034/B.Ed/TS/2017-18/94105 dated 21.07.2017 to the institution reduce the intake from 2 units to 1 unit

AND WHEREAS, as per the decision 369th Meeting of SRC held on 28.01.2019 a Show Cause Notice to be issue to all such institution which have not submitted compliance. Accordingly, a show cause notice was issued to the institution on 26.03.2019

AND WHEREAS, the SRC in 381th meeting held on 31st Oct & 1st Nov. 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Repost accompanied with requisite documents. As per the decision of SRC a final show cause notice was issued to the institution on 22.11.2019. The institution vide letter dated 12.12.2019 received on 18.12.2019 submitted its reply to the final show cause notice along with the documents.

AND WHEREAS, the SRC in its 387th Meeting held on 24th – 25th August, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution on 18.12.2019. The Committee observed and found the following deficiencies: -

- 1. The institution has not submitted certified copy of land document.
- 2. Total land area is not mentioned in LUC.
- 3. Site plan does not show built-up area, site area and multipurpose hall area.
- 4. Multipurpose hall size not mentioned in BCC.
- 5. The institution has not submitted Form "A" issued by the respective bank manager towards creation of FDR of Rs. 7 lakhs and 5 lakhs.
- As required staff list, the institution has mentioned "Already submitted" However, according to the FSCN the institution is required to submit Latest staff list as per the prescribed format duly approved by Registrar of the affiliating body.

Hence, the Committee decided to withdraw the recognition granted to Thorrur College of Education, # 12-86, Khamman HighWays Thorrour Mandal Warangal – 506163, Andhra Pradesh for conducting B.Ed. course w.e.f. the 2020-21 academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, ti Southern Regional Committee hereby withdraws recognition of Thorrur College of Education, No. 12-86, Khammam Highways, Thorrur Mandal, Warangal District-506163, Telangana run by Vishnu Educational Society, Warangal District, Telangana for conducting B.Ed. programme of two year duration with an annual intake of 50 students (1 unit) w.e.f the next academic session.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTF Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such

course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
