WHEREAS, recognition was granted to the institution namely St. John's College of Education, Agape Centre, Chengicherla Village, Boduppal Post, Ghatkesar Mandal, Rangareddy District-500039, Andhra Pradesh run by Christian Outreach Uplifted New Tribes, Rangareddy District, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/2191 dt. 01.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.02.2015 for its willingness for adherence of provisions of new Regulations. A Revised Provisional Recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-16.

AND WHEREAS, the SRC in its 368th meeting held during 08th - 09th January, 2019 considered the matter and decided to issue SCN. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 17.01.2019. The institution did not reply to the show cause notice till date.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on 11.10.2019. The institution vide letter dated 23.10.2019 submitted its reply to the final show cause. The SRC in its 382nd meeting held on 26th - 27th November, 2019 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following deficiency/observations were made:-

- (i) The institution submitted a photocopy of staff list which is not in the standard format and also not approved by the competent authority. The institution has also not appointed the faculty for Fine Arts, Performing Arts & Physical Education Teaching.
- (ii) The institution submitted photocopy of FDRs of Rs. 3 lakhs & Rs. 5 lakhs with maturity date 12.08.2009 & 18.08.2009 against the requirement of 7+5 Lakh. The institution not submitted form A issued by the nationalized bank.
- (iii) The institution submitted photocopy of Completion Certificate which is not in the standard format. The same is not approved by the competent Govt. authority.
- (iv) The institution submitted photocopy of building plan situated at Chengicherla Village & GP, Ghatkesar Mandal, R.R.Dist, AP approving authority stamp and signature is in regional language. Survey number not mentioned.
- (v) The institution submitted a photocopy of Land Use Certificate approving authority stamp and signature is in regional language

Hence, the Committee decided to withdraw the recognition granted to St. John's College of Education, Agape Centre, Chengicherla Village, Boduppal Post, Ghatkesar Mandal, Rangareddy District-500039, Telangana for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of St. John's College of Education, Agape Centre, Chengicherla Village, Boduppal Post, Ghatkesar Mandal, Rangareddy District-500039, Andhra Pradesh run by Christian Outreach Uplifted New Tribes, Rangareddy District, Andhra Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 students (2 units) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
