WHEREAS, the recognition was granted to the institution namely UPR College of Education, No.641, Chennai Bangalore Highway, Thulangum Village, Kancheepuram-631502, Tamilnadu vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed./2008/5038 dt.22.09.08 (P-350-352/Coors.) for conducting B.Ed. course of one year' duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 13.02.2015 (P-354-355/Coors.) for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 01.05.2015 (P-357-358/Coors.) for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, on the basis of decision taken by the SRC in its 369<sup>th</sup> meeting held on 28.01.2019, a Show Cause Notice was issued to the institution dt.31.01.2019 (P-372-373/Coors.) with the direction to submit compliance of RPRO.

**AND WHEREAS,** the institution vide letter dated 15.06.2019 has requested for closure of B.Ed. Programme, along with the following documents:

- 1. Filled in form for online application for permission to close teacher education programme.
- 2. Management resolution copy.
- 3. No dues certificate from the teacher educators.
- 4. Photocopy of Pan of the institution.
- 5. Letter applied to TNTEU for issuing no objection certificate for closing of institution.

AND WHEREAS, the SRC in its 379<sup>th</sup> meeting held on 21<sup>st</sup> – 22<sup>nd</sup> August 2019 considered the matter and decided as under;

The Committee decided that to withdraw the recognition granted to UPR College of Education, No.641, Chennai Bangalore Highway, Thulangum Village, Kancheepuram-631502, Tamilnadu for conducting B.Ed. course under clause 17(1) of NCTE Act, 1993 on the request of the institution vide its letter dated 15.06.2019. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course
