WITHDRAWAL ORDER**

WHEREAS, the recognition was granted to the institution namely **Sri Sardar Butasingh B.P.Ed College, Imangala, Hiriyur Taluk, Chitradurga Dist- 577501, Karnataka** run by **District Madakari Nayaka Association, Chitradurga District, Karnataka** vide SRC (NCTE) order no. F.SRO/NCTE/B.P.Ed/2006-2007/6024 dt. 02.07.2007 for conducting B.P.Ed. course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 06.02.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, a revised provisional recognition order was issued to the institution on 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC in its 369th meeting decided to issue common SCN to all such institutions (one unit or two or more unit cases) asking to submit details regarding additional facilities, additional infrastructure, additional fund, additional staff as per Regulation, 2014. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 19.06.2019. The institution did not submit reply to show cause notice till date. Again as per the decision of SRC a show cause notice was issued to the institution on 30.07.2019. The institution did not submit reply to show cause notice till date.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per decision taken at its 380th meeting. The Sub-Committee of the SRC to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, a Final Show Cause Notice was issued to the institution on 14.10.2019. The institution submitted reply to the Final Show Cause Notice along with documents on 21.11.2019

AND WHEREAS, the SRC in its 384th meeting held on 12th -13th February, 2020 considered the matter and decided as under- :

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 30.07.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 14.10.2019. The institution vide letter dated 21.11.2020 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under :-

1. The institution has not submitted certified copy of registered land duly approved by the competent govt. authority.

2. The institution has not submitted LUC of English version duly approved by the competent authority.
3. The institution has submitted NEC in regional language. The institution is required to submit notarized translated version in English of latest NEC.
4. The building plan submitted by the institution was not approved by the competent authority. Size of multipurpose Hall also not reflected.
5. The institution has submitted BCC which is not approved by the competent authority. The size of multipurpose hall is not reflected in BCC.
6. The institution has not submitted staff proforma in prescribed format as per NCTE guidelines.
7. The institution has not submitted Form A. The institution submitted photocopy of FDRs of Rs 5+3 Lakh against the requirement of 7+5 Lakh as per NCTE Regulations 2014.

Hence, the Committee decided to **withdraw the recognition** granted to **Sri Sardar Butasinghji B.P.Ed College, Imangala, Hiriya Taluk, Chitradurga District-577501, Karnataka** for conducting **B.P.Ed** course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

NOW THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Sri Sardar Butasinghji B.P.Ed College, Imangala, Hiriya Taluk, Chitradurga Dist- 577501, Karnataka** run by **Distict Madakari Nayaka Association, Chitradurga District, Karnataka** for conducting **B.P.Ed** programme of two year duration with an annual intake of 100 students (1 unit) from the next academic session starts after issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
