WHEREAS, Recognition was granted to the institution namely Sruthi College of Education, 13-13-29, Gandhi Nagar, 3rd Street, Nidadavole-534301, West Godavari District, Andhra Pradesh run by Maddala Educational Society, D.No. 13-13-29, Gandhi Nagar, 3rd Street, Nidadavole-534304, West Godavari District, Andhra Pradesh vide SRC (NCTE) order no. F. SRO/NCTE/APSO7530/B.Ed/2007-2008/11857 dt. 25.09.2007 for conducting B.Ed course of one-year duration with an annual intake of 100 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 20.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter provisional revised recognition order was issued to the institution on 20.03.2015 for conducting B.Ed. course of two years duration with an annual intake of100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the SRC was issued a vide Corrigendum Order No. F.SRO/NCTE/APSO7530/B.Ed/AP/2015/68576 to the institution on 29.06.2015.

AND WHEREAS, the SRC in its 368th meeting held on 08th – 09th January, 2019 considered the matter and decided to issue show cause notice. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 18.01.2019. **The institute did not reply to the show cause notice**.

AND WHEREAS, the matter was further considered by the Sub-Committee constitute by the SRC as per decision taken in its 380th meeting. The Sub-Committee of the SRC decided to issued Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly, as per the decision of SRC, a Final Show Cause Notice was issued to the institution on 11.10.2019. The institution vide letter dated 05.11.2019 submitted reply to the Final Show Cause Notice.

AND WHEREAS, the SRC in its 383rd Meeting held on 7th, 8th and 9th January 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 18.01.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 11.10.2019. The institution vide letter dated 05.11.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

- The institution has not submitted LUC duly approved by the competent authority. (i)
- (ii) The institution has submitted Building Plan where the Multipurpose Hall is not reflected.
- The institution has not submitted BCC duly approved by the competent authority. (iii)
- The institution has not appointed the faculty of Fine Arts. (iv)
- (v) The institution has not submitted Form A issued by the Bank authorities/ FDR amounting to Rs.12 lakhs as per NCTE norms.

Hence, the Committee decided to withdraw the recognition granted to Sruthi College of Education, 13-13-29, Gandhi Nagar, 3rd Street, NIdadayole-534301, West Godavari District, Andhra Pradesh for conducting B.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
