WITHDRAWAL ORDER

WHEREAS, recognition was granted to the institution namely Vamsadhara College of Education, Kotabommali, Srikakulam District- 532195, Andhra Pradesh run by Sri Kothammathali Educational Society, Kotabommali, Srikakulam District- 532195, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2007-2008/14484 dt. 12.11.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2007-2008.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the Institution is submitted affidavit dt 19.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, thereafter, provisional revised recognition order was issued to the institution on 06.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

AND WHEREAS, the matter was considered in 363rd meeting of SRC held on 17th – 19th September, 2018 and decided to issue show cause notice to the institution. Accordingly, a Show Cause Notice was issued to the institution on 17.10.2018. The institution submitted its reply to the show cause notice along with documents on 08.11.2018.

AND WHEREAS, AND WHEREAS, the SRC in 381st meeting held on 31st Oct & 1st Nov, 2019 decided to issue Final Show Cause Notice to all such institution where reply of SCN has not been submitted by the institution. Accordingly, as per the decision of SRC a show cause notice was issued to the institution on 10.12.2019. The institution submitted reply to the Final Show Cause Notice along with a letter on 17.01.2020.

AND WHEREAS, the SRC in its 384th Meeting held on 12th and 13th February 2020 considered the matter and decided as under:-

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 08.11.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 10.12.2019. The institution vide letter dated 17.01.2020 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found that the institution has not submitted requisite documents mentioned in Show Cause Notice & Final Show Cause Notices. The Committee observed the following deficiency:-

- (i) The building plan submitted by the institution is not approved by the competent authority.
- (ii) Multipurpose hall has not been shown in the Building Plan and BCC.
- (iii) Certified copy of the land documents not submitted by the institution.
- (iv) Latest staff list approved by the affiliating body not submitted by the institution.

Hence, the Committee decided to **withdraw the recognition** granted to **Vamsadhara College of Education, Kotabommali, Srikulam District-532195, Andhra Pradesh** for conducting **B.Ed course** w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course or training in teacher education after the coming into force of the order withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
