ORDER

WHEREAS, the recognition was granted to the institution, namely Vickram Teacher Training College, Sreenivasa Gardens, Madurai Sivagangai Road, Enathi – 630561, Sivagangai District, Tamil Nadu run by Srinivas Trust, No – 7, Commanding Officers Second Lane, West Masi Street, Madurai District – 625001, Tamil Nadu forconducting M.Ed. course of one year duration with an intake of 25 students on 08.08.2008.

AND WHEREAS, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to Vickram Teacher Training College, Sreenivasa Gardens, Madurai Sivagangai Road, Enathi – 630561, Sivagangai District, Tamil Nadu for M.Ed Course on 24.08.2010 with effect from the session 2010-2011.

AND WHEREAS, after promulgation of NCTE Regulations, 2014, the institution by a notarized affidavit dated 20.01.2015 consented to come under new Regulations.

AND WHEREAS, thereafter, the Southern Regional Committee (NCTE) issued the revised provisional recognition order dt. 22.05.2015 to Vickram College Of Education, Sreenivasa Gardens, Enathi Village, Madurai Sivagangai Road, Sivagangai District – 630561, Tamil Nadu for conducting M.Ed. course of two years duration with an annual intake of 50 students [One basic unit of 50 students] from the academic session 2015-2016 subject to fulfilment of conditions mentioned therein.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance.

AND WHEREAS, a Show Cause Notice was issued to the institution on 18.02.2019. The institution has submitted its reply on 02.03.2019 in respect of SCN issued above.

And whereas, the SRC in its 379^{th} meeting held on $21^{st} - 22^{nd}$ August, 2019 considered the matter and decided as under: -

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The Committee noted that the institution vide letter dated 22.2.2019 has requested for withdrawal of recognition for M.Ed. programme. Therefore, the Committee decided that to withdraw the recognition granted to Vickram Teacher Training College, Sreenivasa Gardens, Madurai Sivagangai Road, Enathi – 630561, Sivagangai District, Tamilnadufor conducting M.Ed. course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the request of the institution. However, the Reserve Fund and Endowment Fund will be refunded by the Regional Director on the submission of the following:

- (a) NOC from the affiliating body.
- (b) NOC from the staff/faculty.
- (c) Resolution of the management to the effect for closure of the course
