**WITHDRAWAL ORDER**

**WHEREAS**, the recognition was granted to the institution namely, Velammal College of Education, Anna Educational Trust, Nambipatti Village H.Doddampaatti (PO) Pappireddipatti Tk, Dharmapuri, Tamilnadu run by Anna Educational Trust, Nambipatti Village, H. Doddampatti (PO) Pappireddipatti Tk, Dharmapuri, Tamilnadu-636903 vide SRC (NCTE) order no. F.SRO/NCTE/2009/12863 dt. 19.05.2009 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

**AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dt. 20.01.2015 for its willingness for adherence of provisions of new Regulations.

**AND WHEREAS**, the revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.

**AND WHEREAS**, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369<sup>th</sup> meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 18.02.2019.

**AND WHEREAS**, the matter was placed before the SRC in its 382<sup>nd</sup> meeting held on 26<sup>th</sup> & 27<sup>th</sup> November, 2019 wherein the Committee considered the matter and decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 09.12.2019.

**AND WHEREAS**, the matter was finally considered by the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> – 13<sup>th</sup> February 2020 decided as under: -

“The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 18.02.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 09.12.2019. The institution vide letter dated 09.01.2020 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under :-

1. The building plan is not approved by the competent authority.
2. The size of M.P. Hall and classrooms mention in the Building plan are less than the requirement of NCTE, Regulations
3. The institution did not submit the original FDRs.

4. The institute did not submit the details of managing trust/society.
5. The institute has not uploaded requisite information on website as required under NCTE, Regulations.
6. The nature of land as per NEC is "Agricultural Land".
7. The Principal namely Ragothaman V. and faculties namely Anbazhagan S., Arivalagan. M, Chitra. D and Jayakumar. P is not qualified.
8. The institute submitted a copy of LUC dt. 25.12.2019, but the same is issued on the letter head of Additional Public Prosecutor cum Additional Govt. Pleader, hence the institute had failed to submit LUC issued by the competent authority.
9. The institute did not submit originally certified copies of Sale Deeds.

Hence, the Committee decided to withdraw the recognition granted to Velammal College of Education, Anna Educational Trust, Nambipatti Village, H. Doddampatti (PO) Pappireddipatti Tk, Dharmapuri, Tamilnadu-636903 for conducting B.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above"

Now therefore, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Velammal College of Education, Anna Educational Trust, Nambipatti Village, H. Doddampatti (PO) Pappireddipatti Tk, Dharmapuri, Tamilnadu-636903 run by Anna Educational Trust, Nambipatti Village, H. Doddampatti (PO) Pappireddipatti Tk, Dharmapuri, Tamilnadu-636903 for running B.Ed course of 2 basic units of 100 students from the end of the academic session. The withdrawal recognition is effective for academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org), with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
