WHEREAS, the recognition was granted to the institution namely, Venkateswara College of Education, Thirumalairaya Samudram, Kalkuruchi Post, Pudukottai District-622303, Tamilnadu run by Venkateswara Educational Trust, Pudukottai District Tamilnadu vide SRC (NCTE) order no. F.SRC/NCTE/2009/M.Ed/RO/13341 dt. 01.06.2009 for conducting M.Ed. course of one-year duration with an annual intake of 25 students.

AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted affidavit dt. 22.01.2015 for its willingness for adherence of provisions of new Regulations.

AND WHEREAS, the revised provisional recognition order was issued to the institution on 23.01.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 (one basic units) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 16.09.2019.

AND WHEREAS, the matter was placed before the SRC in its 380th meeting held on 18th -19th September 2019 wherein the Committee considered the matter and decided to issue Final Show Cause Notice. Accordingly, Final Show Cause Notice was issued on 03.12.2019.

AND WHEREAS, the matter was finally considered by the SRC in its 384^{th} meeting held on $12^{th} - 13^{th}$ February 2020 decided as under:-

The Management of the Institution had not submitted required documents in response to Show Cause Notice (SCN) issued to the Institution on 16.06.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 03.12.2019. The institution vide letter dated 24.12.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

- 1. The institute did not submit certified copy with notarized English translation of land documents.
- 2. The LUC is not in proper format of State Government.
- 3. The institute did not submit notarized English translation of NEC.
- 4. The Building Plan is neither approved nor legible.
- 5. Domain name of the website being run by the institution with uploading of requisite information not provided.
- 6. The BCC is not approved by the competent authority.
- 7. Signature of Registrar on the proforma of faculty are not legible.

- 8. FDRs for Endowment fund and Reserve Fund are not maintained as per NCTE Regulations for 12 Lakh for each course.
- 9. Earmarked area for both courses have not been reflected in the building plan.

Hence, the Committee decided to withdraw the recognition granted to Venkateshwara College of Education, Thirumalairaya Samudram, Kalkuruchi Post, Pudukottai District-622303, Tamilnadu for conducting B.Ed. & M.Ed courses w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Now therefore, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to Venkateswara College of Education, Thirumalairaya Samudram, Kalkuruchi Post, Pudukottai District-622303, Tamilnadu run by Venkateswara Educational Trust, Pudukottai District Tamilnadu for running M.Ed course of 2 basic units of 100 students from the end of the academic session. The withdrawal recognition is effective for academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993, through "online mode" available on NCTE's website www.ncte-india.org, with 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
