WHEREAS, the institution namely Stanley College of Education, Stanley Educational Trust, Dharmapuri Main Road, Pappireddipatti Town, Pappireddipatti Post, Dharmapuri, Tamilnadu-636905 was granted recognition vide SRC (NCTE) order no. F.SRO/NCTE/2008/M.Ed./RO/7249 dt. 24.11.2008 for conducting M.Ed. course of one-year duration with an annual intake of 25 students. The consequent upon the notification of the National Council for Teacher Education (Amendment) Regulation, 2010 on dt. 26.07.2010 the intake of existing 25 students in M.Ed. course was increased from 25 to 35 vide SRC, NCTE order dt. 25.08.2010.

AND WHEREAS, the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution dt. 05.05.2015 by the institution, the provisional revised recognition order was issued to the institution on 25.05.2015 for conducting M.Ed. course of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-16.

AND WHEREAS, as per decision taken by Committee in a Show Cause Notice was issued to the institution on dt. 18.02.2019. Thereafter, a final show cause notice was issued on 18.11.2019. Thereafter, the institution submitted its reply along with documents on 02.12.2019.

AND WHEREAS, the SRC in its 384th meeting held on 12th -13th February 2020 considered the matter and decided as under: -

The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Management of the Institution had not submitted required documents in response to letter issued to the Institution on 18.02.2019. Another opportunity was given to the institution by serving a Final Show Cause Notice (FSCN) dated 18.11.2019. The institution vide letter dated 02.12.2019 submitted its reply/representation in response to Final Show Cause Notice (FSCN). On perusal of the same the Committee found the following defects / shortcomings / deficiencies as per provisions of the NCTE Regulations, 2014 which are as under:-

1. The institute did not submit originally certifies copy of Land documents.

2. The LUC is not on the letter head of issuing authority. The institute did not submit notarized copy of LUC.

- 3. The building plan is neither approved nor legible.
- 4. The institution has submitted xerox copy of NEC in English version.
- 5. BCC neither approved nor legible.
- 6. The institution did not submit the original FDRs.
- 7. The institute did not submit the details of managing trust/society.
- 8. The institute has not uploaded requisite information on website as required under NCTE, Regulations.
- 9. The faculty namely K. Mariammal, S. Jawaharlal Nehru, Assistant Professor are not eligible NCTE, Regulations.
- 10. The faculty is not sufficient for one unit of M.Ed. course.

Hence, the Committee decided to withdraw the recognition granted to Stanley College of Education, Stanley Educational Trust, Dharmapuri Main Road, Pappireddipatti Town, Pappireddipatti Post, Dharmapuri, Tamilnadu-636908 for conducting M.Ed course w.e.f. the next academic session under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above.

Now therefore, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby_withdraws recognition granted to Stanley College of Education, Stanley Educational Trust, Dharmapuri Main Road, Pappireddipatti Town, Pappireddipatti Post, Dharmapuri, Tamilnadu-636905 run by Stanley Educational Trust, Mookareddipatti, A. Pallipatti-Po, Pappireddipatti, Dharmapuri- District-636905, Tamil Nadu vide SRC (NCTE) order no. F.SRC/NCTE/2008/M.ED/RO/7249 dated 24.11.2008 for running M.Ed course of one basic units of 50 students from the end of the academic session. The withdrawal recognition is effective for academic session commences next to issuance of this order.

Further, the institution and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act: -

"If an institution offers any course or training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an appeal u/s 18 of the NCTE Act, 1993, through "Online mode" available on NCTE's website http://ncte.gov.in, within 60 days from the date of issue of this order. The guidelines for filling appeal may be seen on NCTE's website.
