In terms of section 15(1) of the NCTE Act, 1993 Arcot Sri Mahalakshmi Womens Teacher Training Institute, Arni Main Road, Near Arcot, Villapakkam Post-632521, Vellore District, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of permission for an additional unit of 50 to offer Elementary course of two years duration from the academic session 2004-05.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - The institution has obtained endorsement from the Government of Tamilnadu for additional unit vide letter No. 35223/U1/2004-1 dated 22.7.2004.
  - The institution has obtained court directions from Hon'ble High Court of Madras to cause inspection for additional unit vide W.P. No. 24837 of 2064.
  - c. The institution has selected a **Principal** and **Eleven** teachers for the said course, which is to be approved by the Director, DTERT, Chennai.
- 3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993 and pursuant to the directions of Hon'ble High Court of Madras, the Regional committee hereby grants permission to Arcot Sri Mahalakshmi Womens Teacher Training Institute, Arni Main Road, Near Arcot, Villapakkam Post-632521, Vellore District, Tamilnadu to offer Elementary course of two years duration from the academic session 2004-05 with an annual intake of 100 students which includes the existing intake of 50 and an additional unit of 50, subject to fulfillment of the following.
  - a. The institution will ensure that **Twelve** faculty members are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Committee immediately and in any case not later than one month from the date of commencement of the course.
  - b. The institution shall, within one month of the receipt of permission order, convert the Endowment fund account into a joint account to be operated along with an official of the Regional Committee.

- c. The institution shall, within one month of the receipt of permission order, create the Reserve fund account equivalent to three months salary of the staff (teaching and non-teaching).
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- e. The institution will offer the course for both the units for the session 2004-2005 and as per the norms of DTERT, Chennai.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of Teacher Education Research and Training (DTERT) to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.
