**ORDER**

**WHEREAS**, on 8.09.2014, a copy of the proceedings of the Director, S.C.E.R.T, Telangana State, Hyderabad dated 30.08.2014 is received by this office regarding change of address of the D.Ed college from New Malakpet to Opp. Govt. Hospital, Nampally, Hyderabad – 500001. the letter states as under :-

*"The attention of the Correspondent / Secretary , Anwarul Uloom college of Elementary, New Malakpet, Hyderabad – 500024 is invited to the reference read above and he is directed to furnish the following documents duly attested on each page related to change of address of the D.Ed college from New Malakpet to Opp. Govt. Hospital , Nampally , Hyderabad – 5000 001:*

- 1) Copy of the F.SRO/NCTE/2009-2010/21262 dated 23.09.2010 of the authorities of the NCTE , SRC, Bangalore
- 2) All the correspondence copies from time to time till date made with the NCTE , SRC, Bangalore

*The above said documents should be submitted to this office by 07.09.2014 without fail. Further the Correspondent concerned is informed that the Principal of the D.Ed College concerned is not competent to make the correspondence with this office."*

**AND WHEREAS**, as per the records , (APS02536/D.Ed) Anwar Uloom College of Elementary, New Malakpet, Hyderabad – 500024, Andhra Pradesh was granted recognition for the conduct of Elementary (D.Ed) course of two years duration from the academic session 2005-2006 with an annual intake of 50 students on 26.08.2005 subject to the condition that the institution shall shift both B.Ed and D.Ed courses to its own premises/ building within three years from the date of recognition of B.Ed college as the recognition for D.Ed is issued based on existence of B.Ed college and Notification dated 01.01.2004 of NCTE( in case the B.Ed/D.Ed course is started in rented premises).

**AND WHEREAS**, SRC in its 195<sup>th</sup> meeting held during 17<sup>th</sup>-18<sup>th</sup> August 2010 observed that the institution has not applied to SRC for shifting of its premises to another location and it was decided to cause inspection of the institution for B.Ed. Course, under Section 17 of NCTE Act, after payment of Rs.40,000/- inspection fee and on submission of filled in Questionnaire, along with relevant supporting documents relating to building, land, including Building Completion Certificate from the competent Government Engineer and Land Use Certificate, within four weeks from the date of confirmation of the Minutes.

**AND WHEREAS**, as per the decision of SRC , a letter was addressed to the institution on 23.09.2010 to submit the relevant documents along with the inspection fee of Rs. 40,000/-

**AND WHEREAS**, On 05.09.2014, the institution has submitted a letter dated 21.08.2014 requesting for change of college premises (D.Ed & B.Ed) Anwar Ul-Uloom college Elementary Teacher Education & Anwar Ul-Uloom college of Education from New Malakpet to Nampally, Hyderabad as under:-

*"It is submitted the management of Anwar ul-Uloom College have shifted the college premises from leased premises at Malakpet to their own building at Nampally, opposite to Government Hospital, Nampally Hyderabad-500001. In this regard management has addressed a letter along with a D.D for an amount Rs.40,000/- vide under reference.*

*Once again the management has requested the Director to issue necessary order for change of both institutions B.Ed and D.Ed in its own building situated at Nampally, Hyderabad. vide under reference 2 cited above.(This institution RC.No.137/Anwr/2010 dated 22.02.2014).*

*Earlier premises was leased one and the management was compelled to vacate immediately. Both colleges (B.Ed. & D.Ed) are functioning in the building situated at Nampally, Hyderabad since 2010-2011. Osmania University committee has visited the college and issued for change of premises from Malakpet to Nampally. Hence it is requested to issue necessary order in this regard."*

The D.D of Rs.40000/- towards inspection fee is not found in the file.

**AND WHEREAS**, SRC in its 273<sup>rd</sup> meeting held during 30<sup>th</sup> September and 1<sup>st</sup> October, 2014 considered the matter and decided as under :-

*"This is a case of shifting that has already taken place. This need not, therefore, put in the 'Freeze' category. Process-obtain documents if not already received.*

The matter of shifting of premises of B.Ed course offered by the College was considered by SRC in its 273<sup>rd</sup> meeting of SRC. The institution is also offering D.El.Ed course and has requested for change of premises of both the courses vide letter dated 21.08.2014. Proceedings of the SCERT dated 30.08.2014 with respect to shifting of premises of D.Ed college has also been received by this office on 08.09.2014.

**AND WHEREAS**, the SRC in its 274<sup>th</sup> meeting held during 30<sup>th</sup> - 31<sup>st</sup> October, 2014 considered the matter, decided and advised Southern Regional Office to:

"Collect all relevant documents for both the courses and process for causing composite inspection."

**AND WHEREAS**, the inspection of the institution was conducted on 04.02.2015 and the VT Report was received by this office on 09.02.2015.

**AND WHEREAS**, as per the decision of SRC in its 280<sup>th</sup> meeting held during 12<sup>th</sup> -14<sup>th</sup> February, 2015 considered the VT report and decided as under:-

- " 1. This is shifting case.
2. Instead of collecting documents SRC has wrongly gone ahead to cause inspection.
3. Now, obtain all documents, including approved staff list of both courses and put up along with the VT inspection report."

**AND WHEREAS**, accordingly, a letter was issued to institution on 18.02.2015. The institution has also submitted the approved staff list of B.Ed and D.Ed. course.

The SRC in its 285<sup>th</sup> meeting held on 17<sup>th</sup> April, 2015 considered the matter, submission of approved staff list of B.Ed and D.Ed course by the institution, and decided to:

**1. Permit Shifting. 2. Ask them to ensure full adherence to the new norms & standards before 30.10.2015.**

**NOW THEREFORE,** permission is hereby accorded by SRC to **Anwar Uloom College of Elementary, New Malakpet, Hyderabad-500024, Telangana** to shift its premises to the new location / building at **Anwar uloom College of Elementary Training Education, No.11-2-400/401, Opposite to Government Hospital, Namapally Hyderabad-500001, Telangana.**

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
