ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 **Baba Teacher Training Institute, Nella-Madurai Road, Kayathar, Thoothukkudi District, Pin-628952, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 31.12.2002.

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for D.T.Ed course on 12.01.2005 with an annual intake of 50 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the institution vide letter dated 26.02.2010 submitted Rs.40000/- for shifting of premises at **Nellai-Madurai Main Road, Kayathur-628952, Thoothukudi District, Tamilnadu**. Accordingly, the inspection of the institution was fixed between 23rd March 2nd April 2011. The same was intimated to the institution on 04.03.2011. Accordingly, the inspection of the institution was conducted on 31.03.2011.

AND WHEREAS, the SRC in its 204th meeting held on 27-28 April 2011 considered the VT report, VCD and all the relevant documentary evidences and decided to serve the show cause notice to the institution. Accordingly, a show cause notice was issued to the institution on 27.05.2011. The institution had submitted its written representation on 27.06.2011.

AND WHEREAS, the SRC in its 211th meeting held on 21-23 September, 2011 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve the Final Show cause Notice under Section 17 of NCTE Act. Accordingly, a Show cause notice was issued to the institution on 17.11.2011. The institution had submitted its written representation on 22.12.2011.

AND WHEREAS, the SRC in its 216th meeting held on 11-12 January, 2012 considered the reply of the institution vide letter dt 22.12.2011, VT report of the institution and other related documents along with the original vide of the institution for shifting to new/permanent premises and decided to
