Preamble:

Read: Notification of NCTE, New Delhi dated 1.1.2004 published in the Gazette of India Part III-Section 4 as No. 3 on 5.1.2004.

The NCTE, New Delhi in its Notification dated 01.01.2004 decided to dispense with the requirement of "No Objection Certificate" from State/UT Government for those institutions already running Elementary programmes recognized by NCTE and seeking recognition to start a course or training in increase in intake for a period of three years from the date of notification of these regulations in the Official Gazette.

Besant LVR Teacher Training Institute, V.R. Nagar, Kovilpatti – 628 502, Tamilnadu which has been granted recognition by SRC-NCTE has submitted an application to start **Elementary increase in intake (D.Ted)** course by deriving the benefit of above said regulation on 31.12.2002.

The application for starting **Besant LVR Teacher Training Institute, V.R. Nagar, Kovilpatti – 628 502, Tamilnadu** was considered by SRC-NCTE under section 15 of NCTE Act, 1993. In obedience to the directions of Hon'ble High Court of Madras in W.P. No. 26764 of 2003 an inspection of the institution was carried out on 04.12.2005. The inspection report was placed before 106th SRC meeting held on 15-16 December, 2005. SRC decided to issue notice to the institution under Section 15(3)(b) of NCTE Act pointing out certain deficiencies mentioned in the visiting team report. Accordingly a notice was issued to the institution on 29.12.2005. The compliance / written representation dated 3.1.2006 submitted by the institution was placed before the SRC in its 109th meeting held on 2nd February, 2006. The SRC considered the written representation and observed that the institution had made satisfactory arrangements in respect of infrastructural and instructional facilities for starting Elementary(D.T.Ed) increase in intake course and decided to permit the institution to start Elementary increase in intake course from the session 2005-06.

Order

In terms of section 15(1) of the NCTE Act, 1993 **Besant LVR Teacher Training Institute, V.R. Nagar, Kovilpatti – 628 502, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of permission for **Elementary** course of two years from the academic session **2005-06** with an **additional intake of 50** students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a. The institution has acquired the land for setting up the teacher education institution.
- b. The institution has constructed the building for conducting the course on the above mentioned land.
- c. The institution has selected the **Principal** and **Eleven** teachers for the said course, which is to be approved by the Director, DTERT, Chennai.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional committee hereby grants permission to **Besant LVR Teacher Training Institute, V.R. Nagar, Kovilpatti – 628 502, Tamilnadu** to offer **Elementary** course of **two years duration** from the academic session **2005-06** with an annual intake of **100** students which includes the existing intake of **50** and an additional intake of **50**, subject to fulfillment of the following.

- a. The institution will ensure that **Twelve** exclusive faculty members (**Principal and Eleven teachers**) duly approved by the DTERT are in position for an intake of **100** students duly approved by the DTERT are in position for an intake of **50** students and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case before commencement of admissions for the course.



- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Regional Committee.
 - c. The institution shall, within one month of the receipt of recognition order, create the Reserve fund account equivalent to three months salary of the staff (teaching and non-teaching).
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of Teacher Education Research and Training (DTER) to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.




