**ORDER**

WHEREAS, VJR Memorial Educational Society, Hanmapur, Bhongir, Nalgonda, Andhra Pradesh had applied for grant of recognition to Bhongir College of Education, Hanumapur, Bhongir, Nalgonda District, Andhra Pradesh submitted an application for grant of recognition to B.Ed course.

AND WHEREAS, the application was processed and recognition was granted for offering B.Ed course with an annual intake of 120 students on 14/08/2000 at Hanumapur, Bhongir, Nalgonda District, Andhra Pradesh.

AND WHEREAS, the institution has submitted its written representation on 01.03.2013 regarding shifting of own premises along with DD of Rs.50,000/- (expired).

AND WHEREAS, a letter was sent to institution for revalidation of original demand drafts on 18.07.2013. The institution has submitted revalidation of Demand Drafts on 05.08.2013 stating that "requesting for shifting to own building for our college".

AND WHEREAS, the Committee in its 251<sup>st</sup> meeting held on 25-27<sup>th</sup> considered the request of the institution for shifting of the B.Ed course to new building & all other relevant documents and decided to cause Composite inspection for B.Ed (APS00047) & APS02804 (D.Ed) course run by the institution under NCTE Act, to examine whether the institution fulfils all the requirements as per the norms, subject to the condition that the deficiencies, if any, were duly rectified by the institution, as per the norms.

AND WHEREAS, accordingly, inspection of the institution was fixed on 7-12<sup>th</sup> October, 2013. The same was intimated to the institution on 27-09-2013.

AND WHEREAS, as per the direction of SRC, the inspection of the institution was conducted on 08/10/2013 and the VT report received in the office of SRC on 11-10-2013.

AND WHEREAS, the SRC in its 255<sup>th</sup> Meeting held on 13<sup>th</sup>-15<sup>th</sup> November, 2013 considered the VT report, VCD of the institution on the above matter and also the relevant documents of the institution and decided to withdraw the recognition of the B.Ed course run by Bhongir College of Education, Hanumapur Village, Bhongir, Nalgonda District-508116, Andhra Pradesh from the academic year 2013-14, in order to enable the ongoing batch of students in B.Ed, course, if any, to complete their course.

AND WHEREAS, but it is made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order. The Affiliating body / Examining board / body be informed accordingly.

AND WHEREAS, further decided to return Endowment funds and Reserve fund deposited with SRC NCTE, Bangalore, if any, after ensuring payments to all dues of faculty and staff.

AND WHEREAS, the VT report was placed before SRC's 255<sup>th</sup> meeting held on 13-15<sup>th</sup> Nov, 2013 and the Committee has decided to 'Reject' the application instead of withdrawal of recognition".

AND WHEREAS, the Committee in its 256<sup>th</sup> meeting held on 04-06<sup>th</sup> December, 2013 has reviewed the decision taken in its 255<sup>th</sup> meeting, decided to correct the mistake of decision as 'Reject' and change it to withdrawal of recognition w.e.f 2013-14.

AND WHEREAS, accordingly, a withdrawal order was issued to the institution on 07.01.2014.

AND WHEREAS, aggrieved by the withdrawal order of SRC, the institution filed an appeal before the appellate authority, NCTE Hqrs.

AND WHEREAS, the appellate authority order F.No. 89-43/2014 Appeal/6<sup>th</sup> Meeting 2014/A88441 dated 29/05/2014 is received by this office on 16/06/2014.

AND WHEREAS, the SRC in its 269<sup>th</sup> meeting held during 1<sup>st</sup> & 2<sup>nd</sup> July 2014, considered the matter, as per the direction of NCTE (H'qrs) that all appeal remand cases should be processed only after notification of the new Regulations. Advised Southern Regional Office to process the case accordingly, and put up after notification of new Regulations as per NCTE (H.Q) instructions.

AND WHEREAS, the institution has submitted the documents along with affidavits requesting to process the application as per Regulation 2014 on 05.01.2015.

AND WHEREAS, the SRC in its 276<sup>th</sup> Meeting held on 07<sup>th</sup>-09<sup>th</sup> January, 2015 considered the matter, reply of the Institution dated 05.01.2015 along with affidavit expressing their willingness to process their application as per Regulations 2014, decided and advised Southern Regional Office to: 1.Restore recognition. 2. Permit shifting 3.Issue revised provisional recognition order.

AND WHEREAS, as per the decision of SRC, Restore recognition and Permit shifting order was issued to the institution on 20.01.2015.

AND WHEREAS, the institution has submitted affidavit on 03.02.2015 as per the regulation 2014. Accordingly, revised recognition order was issued to the institution on 18.03.2015.

AND WHEREAS, the institution has submitted a letter dated 11.11.2015.

AND WHEREAS, the SRC in its 295<sup>th</sup> Meeting held on 28<sup>th</sup> – 30<sup>th</sup> November, 01<sup>st</sup> December 2015, considered the matter, letter dated 11.11.2015 from the institution and decided as under;

- **The applicant's request is accepted. It was an omission not to mention D.El.Ed in the shifting order. Please issue a corrected order.**

NOW THEREFORE, permission is hereby accorded to **Bhongir College of Elementary Education, Hanmapur, Bhongir, Nalgonda District – 508233, Andhra Pradesh (APS02804 - D.El.Ed) and (SRCAPP1290 – D.El.Ed-AI) to shift its premises to new location/building at Bhongir College of Elementary Teacher Education, Sy.No.131/0, 132, Anantharam Village, Bhongir Mandal, Nalgonda District – 508116, Telangana.**

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
