WHEREAS, Christian College of Education, II-250/E/4/3A, Reddy's Colony, Mananpalle, Chittoor District-517325, Andhra Pradesh had submitted application for grant of recognition to B.Ed course on 06/03/2006, the application was processed and recognition was granted for offening B.Ed course with an annual intake of 100 students on 12/04/2007 at Christian College of Education, II-250/E/4/3A, Reddy's Colony, Mananpalle, Chittoor District-517325, Andhra Pradesh with a condition that the institution shall shift to its own premises / building within three years from the date of recognition (in case the course is started in rented premises)

AND WHEREAS, the institution has submitted its written representation along with DD of Rs 40,000/stating as follows:

"NCTE — accorded permission to start B.Ed., College in the name of Christian College of Education bearing No. APSO 6304 in Madanapalle, Chittoor District Andhra Pradesh by following the norms of NCTE in the Door No. II-250/4/3A, Reddy's Colony, Madanapalle

Now we want to shift the notlege promises nearer to the earlier place which is quite convenient and also suitable to the norms of NCTE. Further we paid Rs. 40,000/- as demand draft bearing No. 295461-SBI MPL towards the fee:

Hence we request to accord shifting permission from II-250/4/3A, Reddy's Colony, Medanapalle to 1-331-2, Sivaleyam Street, Madanapalle".

AND WHEREAS, the Southern Regional Committee in its 250<sup>th</sup> meeting held on 11<sup>th</sup> – 13<sup>th</sup> August 2013, has considered the above matter and decided to Ask institution to submit all land and building documents and approved staff list for causing inspection of new premises. As per the decision of SRC a letter was sent to the institution on 30.09.2013. The institution has submitted a written representation on 23.06.2014.

AND WHEREAS, the Southern Regional Committee in its 269° meeting held during 1°-2° July, 2014, has considered the above matter and decided to ask institution to submit all land and building documents and approved staff list for causing inspection of new premises. In the meanwhile on 09 07 2014, the correspondent of institution has submitted a letter stating which as is under-

"We have applied for the shifting of the college premises to new premises. For that I have submitted the relevant documents to the NCTE authorities. We came to know that our college subject came for the decision in 269" meeting of SRC NCTE.

As the website of NCTE SRC is not functioning. I came to Bangalore for the details. Here I saw that my case was wrongly entered as consideration of others instead of consideration for shifting.

Further I observed that I should show the originals to the V.T. while inspection. It is bring to your kind notice that all the original documents are with the NCTE authorities. So I may be allowed to show the Xerox copies of the relevant documents to the visiting team.

Hence, I request the NCTE authorities to consider my case shifting and also allow me to show the Xerox copies to V.T."

AND WHEREAS, the institution has submitted the following documents along with affidavit to process the application as per NCTE Regulations on 26:12:2014

AND WHEREAS, the institution has submitted a D.D. of Rs.10.000/-, dated 17.06.2014 drawn in favour of Member Secretary, payable at Bangalore. The institution had submitted Rs. 40,000/- vide D.D.No. 295461 dated 20.06.2013 which was already taken into account vide this office receipt No. 17065 dated 15.07.2013 towards inspection.

AND WHEREAS, the SRC in its 276" Meeting held during 07-09 January, 2015 considered the matter, written representation of the institution for shifting dated 23.06.2014, reply of the Institution dated 26.12.2015 along with affidavit expressing their willingness to process their application as per Regulations 2014, decided and advised Southern Regional Office to Cause Inspection of the said institution. As per the decision of SRC, an inspection letter issued to the institution on 28.01.2015. The inspection of the institution was conducted on 01.02.2015 and the VT Report was received by this office on 05.02.2015.

AND WHEREAS, the SRC in its 280<sup>th</sup> meeting held during 12<sup>th</sup> - 14<sup>th</sup> February, 2015 considered the matter, VT report dated 01.02.2015, VCD of the institution, and all relevant documentary evidence and decided to serve Show cause Notice under NCTE act, for the following deficiencies.

The institution to submit duly approved staff list.

AND WHEREAS, as per the decision of SRC, a Show Cause Notice was issued to the institution on 27.02.2015. The institution has submitted a written representation on 07.04.2015.

AND WHEREAS, the Southern Regional Committee in its 285° meeting held on 17° April 2015, considered the reply to the show cause notice vide their letter dated 07.04.2015 and decided to permit Shifting of premises for 8.Ed.

NOW THEREFORE, permission is hereby accorded by SRC to Christian College of Education, II-250/E/4/3A, Reddy's Colony, Madanpalle, Chittoor District-517325, Andhra Pradesh to shift its premises to the new location / building at Christian College of Education, 1-331-2, Sivalayam Street, Opp. Arogyamatha High School, Madanapalle, Chittoor District - 517325, Andhra Pradesh.

if the institution contravenes any of the conditions or the provisions of the NCTE Act. Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Further, the institution has submitted affidavit on 26:12:2014, as per regulations 2014 and the revised order for the academic year 2015-16 is under:

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009 the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- AND WHEREAS, the institution, Christian College of Education, 1-331-2, Sivalayam Street, Opp. Arogyamatha High School, Madanapalle, Chittoor District - 517325, Andhra Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
  - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds; (d) additional staff as per Regulations; 2014 and inform Regional Committees with required documents by October 31, 2015.
  - The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforms available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- 4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee NCTE hereby grants recognition to Christian College of Education, 1-331-2, Sivalayam Street, Opp. Arogyamatha High School, Madanapalle, Chittoor District 517325, Andhra Pradesh for conducting B.Ed programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31 10.2015
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations. and always display following as mandatory disclosure:
  - a) Sanctioned programmes along with annual intake in the institution:
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - Name of faculty members who left or joined during the last, quarter:
  - d) Names of Students admitted during the current session, along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.,
  - e) Fee charged from students;
  - Available infrastructural facilities;
  - g) Facilities added during the last quarter,
  - Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - The affidavit with enclosure submitted along with application.
  - The institution shall be free to post additional relevant information, if it so desires.
  - K) Any faise or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules. Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NOTE Act.
