PREAMBLE:

Christian Teacher Training Institute for Women, Mountzion, Cholapuram south, Rajapalyam Via, Virudhunagar District-626139, Tamilnadu submitted an application seeking grant of recognition for D.T.Ed course on 19.12.1996 without NOC from the State Government of Tamilnadu. The application of the institution was returned back vide this office letter dated 31.3.2000 quoting non submission of NOC as required under Regulation 5(e), Section 14 of NCTE Act. The institution resubmitted their application along with other documents on 9.3.2005.

In obedience to the directions passed by the Hon'ble High Court of Madras in W.P. No. 4000 of 2005 and W.P.M.P. No. 4471 of 2005 dated 10.2.2005 filed by the institution SRC-NCTE caused inspection of the institution on 11.6.2005. The visiting team report of the institution was placed before 97<sup>th</sup> SRC meeting held on 27<sup>th</sup> July, 2005. SRC decided to issue notice to the institution under Section 14(3)(b) of NCTE Act mentioning certain deficiencies. The institution has submitted their written representation dated 12.09.2005 fulfilling the deficiencies pointed out by SRC. The same was placed before the 100<sup>th</sup> SRC meeting held on 23<sup>rd</sup> - 24<sup>th</sup> September, 2005. SRC decided to accord recognition to the institution to offer D.T.Ed. course from the academic session 2005-06 with an intake of 50 students. Hence the order :

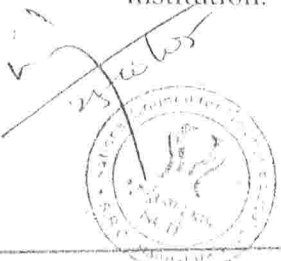

**ORDER**

In terms of Section 14 (1) of the NCTE Act, 1993 **Christian Teacher Training Institute for Women, Mountzion, Cholapuram South, Rajapalayam Via, Virudhunagar Dist. - 626 139, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for **Elementary (D.T.Ed) Teacher Training** Course of two years duration from the academic session **2005-06**.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- The institution has submitted a court direction for considering their proposal.
- The institution has acquired the land for setting up the teacher education institution.

- c. The institution will ensure that the permanent building is constructed within a period of 3 years on the acquired land.
- d. The institution has created an Endowment fund of Rs. 5.00 lakhs and a Reserve fund of Rs. 3.00 lakhs.
- e. The institution has selected the **Principal** and **five** teachers for the said course.
- f. The institution has submitted Endorsement issued from the State Government dated 01.09.1998.
- g. The institution has submitted a court direction issued by the Hon'ble High Court of Madras in W.P. No. 9761 of 1993 and W.P.M.P. No. 15031 of 1993 with a direction to consider the institution as an existing one.

3. Now therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Christian Teacher Training Institute for Women, Mountzion, Cholapuram South, Rajapalayam Via, Virudhunagar Dist. - 626 139, Tamilnadu** to offer **Elementary(D.T.Ed)** course of **two years duration** from the academic session **2005-06** with an annual intake of **50** students, subject to fulfillment of the following.

- a. The institution will ensure that **Six** exclusive faculty members (**Principal and five teachers**) duly approved by the DTERT are in position for an intake of **50** students and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case before commencement of admissions for the course.
- b. The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).
- c. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating authority to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

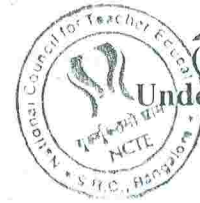
