ORDER

WHEREAS, Adarsha Educational Society, D No. 9-1, CLR Complex, Nehru Nagar, Cumbum-523 333, Andhra Pradesh had applied for grant of recognition to Chaitanya College of Education, No.121/1, Nehrunagar, Kandulapuram, Cumbum, Prakasam-523333, Andhra Pradesh for D.El.Ed Course of two years duration under Section 14(1) of the NCTE Act, 1993 to the Southern Regional Committee, NCTE on 06.10.2009.

AND WHEREAS, the Application was scrutinized and a copy of application was sent to State Government for recommendation on 09.11.2010/02.02.2011. A deficiency letter was issued to the institution on 09.12.2010.

AND WHEREAS, the Southern Regional Committee in its 202nd Meeting held on 14th and 15th March 2011 considered the reply of the institution dt.04.20.2011, 21.02.2011 and 28.20.2011 and decided to cause inspection, accordingly institution was conducted on 31.03.2011.

AND WHEREAS, SRC in its meeting 204th considered the VT report and decided to issue Show Cause Notice .As per the decision of Committee Show Cause Notice was issued on 26.05.2011. The institution submitted its reply to Show Cause Notice on 25.05.2011.

AND WHEREAS, Southern Regional Committee in its 206th Meeting held on 09th and 10th June 2010, on careful perusal of the original file of the institution, reply of the institution and other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, the Regional Committee decided to issue <u>Letter of Intent</u> prior to grant of recognition, as per direction of SRC LOI was issued to the applicant institution on 15.06.2011. Institution has not submitted reply to LOI.

AND WHEREAS, the matter was placed before 210th Meeting of SRC held on 22nd - 23rd August, 2011, due to non submission of LOI reply the by the institution. The SRC considered the matter and decided to decided to issue a Show cause Notice to the institution as to why the LOI be not withdrawn and thereby providing an opportunity to the institution to make a written representation within 30 days from the date of issue of the Notice along with necessary certificates/documents in order to take a final decision in the matter; failing which action will be taken including the withdrawal of LOI based on the records available, with no further notice.

AND WHEREAS, meanwhile in response to LOI dt. 15.06.2011 the institution submitted its reply vide letter dated 24.10.2011. The matter was placed in 212th SRC meeting held on 24th October 2011. The committee considered the reply to LOI submitted by the Institution and decided to issue Formal Recognition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Chaitanya College of Education, No.121/1, Nehrunagar, Kandulapuram, Cumbum, Prakasam-523333, Andhra Pradesh for conducting D.El.Ed Course of two years duration with intake of 50 Students from the academic session 2012-2013 under clause 7(11) of NCTE Regulations, 2009 subject, to fulfillment of the following conditions:

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- iv The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- v The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- vi The institution / Management shall produce valid minority certificate from the notified authority of the respective State Government for the subsequent years 2012-13 onwards.

Further Southern Regional Committee in its 208th Meeting held on 13th and 14th July 2011 also resolved that the institutions which have fulfilled all the requirements as per norms and regulations excepting the minority certificate be directed to submit a notarized statement/ undertaking:-

- 1. The Institution shall declare themselves as minority trust and minority institution proposed to be established and
- 2. Giving an undertaking that the management shall produce valid minority certificate from the notified authority of the respective State Government on or before 31st March 2012, failing which, the institution shall be de recognized automatically without any further notice and that such institutions shall make no further admission thereafter.
- 3. The said institution has submitted conditional certificate only for 2011-12 and for 2012 -2013 as such requisite undertaking may be submitted immediately.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
