ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

AND WHEREAS, the institution Chikkodi Taluka Education Society's College of Physical Education (B.P.Ed), C/o, R.D. Composite PU College Campus, Chikkodi Taluk, Belgaum District-591201, Karnataka has by affidavit consented to come under New Regulations and sought for 100 intake in B.P.Ed.

AND WHEREAS, it has been decided to permit the institution to have one basic unit of 100 students (two sections of 50 each) subject to the institution fulfilling following conditions namely.

- The institution shall appoint additional staff as per Regulations, 2014 and submit approved staff list to the Regional Committees with required documents by October 31, 2015. 1
- The Regional Committees chall arrange for verification of documents, check adherence by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with the new teaching staff requirements, the institution shall not be permitted to admit students for the academic year 2016-2017. 11.

4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE, Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Chikkodi Taluka Education Society's College of Physical Education (B.P.Ed), C/o. R.D. Composite PU College Campus, Chikkodi Taluk, Belgaum District-591201, Karnataka for conducting B.P.Ed programme of two years duration with an annual intake of one basic unit of 100 (two sections of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned here in before 31.10.2015.

Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable:

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

7. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:

- a) Sanctioned programmes along with annual intake in the institution;
 b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 c) Name of faculty members who left or joined during the last, quarter;
 d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission etc. admission, etc.
