ORDER

In terms of Section 14(1) of the NCTE Act, 1993 The Chikkodi Taluka Education Society, Chikkodi, Belgaum District, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to The Chikkodi Taluka Education Society's College of Education, C/o. R.D. Complex, P.U.College Campus, Chikkodi-591201, Belgaum District, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2004-05 with an annual intake of 100 students.

On scrutiny of the application submitted by the institution the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- 1. The institution has acquired the land for setting up the teacher education institution.
2. The institution has constructed the building for conducting the course on the above mentioned land.
3. The institution has created an Endowment Fund of Rs.5 lakh and a Reserve Fund of Rs. 3.5 lakh.
4. The institution has selected the Principal and Seven (sevens) lecturers for the said course and the list of faculty members has been approved by the affiliating University.
5. Now, therefore, in exercise of the powers vested under Section 14(1)(b) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to The Chikkodi Taluka Education Society's College of Education, C/o. R.D. Complex, P.U.College Campus, Chikkodi-591201, Belgaum District, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2004-2005 with an annual intake of 100 students subject to submission of the following:
6. The institution will ensure that Principal and Seven (sevens) faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (1) of Section 14 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in pursuance of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2006, the National Council for Teacher Education has notified the Regulations, 2004 on 13-2-2004

2. AND WHEREAS, the institution The Chikkodi Taluka Education Society's College of Education, C/o. R.D. Complex, P.U. College Campus, Chikkodi-591201, Belgaum Karnataka has by affidavit consented to come under NCTE regulations and sought for grant of recognition to the said course of one year duration.

3. AND WHEREAS, it has been decided to grant the institution the status of one year college of education subject to the institution fulfilling following conditions namely:

- 1. The institution shall create additional lands as per Regulations, 2004 and inform Regional Committee with required documents by October 31, 2015.

4. NOW THEREFORE, in the light of the above said terms of Section 14(1)(b) of NCTE Act and in pursuance of the Regulations, 2006, the Southern Regional Committee, NCTE hereby grants recognition to The Chikkodi Taluka Education Society's College of Education, C/o. R.D. Complex, P.U. College Campus, Chikkodi-591201, Belgaum, Karnataka for conducting B.Ed programme of one year duration with an annual intake of 51 students (one unit) from the academic session 2015-16.

5. Further the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like JGC, affiliating University/BOD, the State Government etc. as applicable.

6. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

7. The institution shall maintain a guide as website as per provisions of NCTE Regulations and always display following as mandatory disclosure:

- a) Name and the registration along with annual intake in the institution.
b) Name of faculty and staff list as mentioned in section mentioned along with their qualifications, scale of pay and job description.
c) Name of faculty members who left or pending the job, position.
d) Name of students admitted during the current session along with qualifications, percentage of marks in the qualifying examination and in the entrance test, if any date of admission etc.
e) Fee charges for students.
f) Available infrastructural facilities.
g) Facilities availed during the last session.
h) Number of books in the library, journal subscribed to and additions, if any, in the last session.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
c. The institution shall shift to its own premises if building within three years from the date of recognition. (in case the course is started in rented premises)
d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
