ORDER

In terms of Section 15(1) of the NCTE Act, 1993 DISTRICT INSTITUTE OF EDUCATION AND TRAINING, L.M.D. COLONY, THIMMAPUR, KARIMNAGAR-505527, ANDHRA PRADESH had submitted an application to the Southern Regional Committee of NCTE for grant of permission for the Additional Intake of 50 students in the Urdu medium section in the existing D.Ed. course of 80 students (Telugu medium) of Two years duration from the academic session 2003-04 i.e., with an annual intake of 130 students.

- 1. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - i) The institution has acquired the land for setting up the teacher education institution.
 - ii) The institution has constructed the building for conducting the course on the abovementioned land.
 - iii) The institution has selected the Principal / Head and 5 teachers for the said course.
- 2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to DISTRICT INSTITUTE OF EDUCATION AND TRAINING, L.M.D. COLONY, THIMMAPUR, KARIMNAGAR-505527, ANDHRA PRADESH for D.Ed. Course of Two years from the academic session 2003-2004 for an additional intake of 50 students in the Urdu medium with an annual intake of 130 students subject to fulfillment of the following:
 - a) The institution will ensure that **5** faculty members duly approved by the affiliating body are in position for the addl. intake of <u>50</u> students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
- The institution shall submit to the Regional Committee a Performance Appraisal Report at the end
 of each academic year along with a copy of the approval of the affiliating University to the
 appointment of faculty members, and the statement of annual accounts duly audited by a Chartered
 Accountant

4. If the institution contravenes any of the above condition or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
