ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education(NCTE) Act, 1993, the Southern Regional Committee grants recognition to District of Education 85 Training, Thiruvananthapuram District, Kerala for Elementary Course of two years Attingal duration from the academic session 2000-2001 with an annual intake of 40, subject to fulfilling the following conditions :

- 1. All such teachers already appointed who do not have qualifications as per NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
- 2. Librarian and Library Assistant should be appointed.
- 3. Instructors for Work Experience, Art & Music and Education Technology should be appointed.
- 4. Psychology lab should be equipped as per NCTE norms.
- 5. Three educational journals should be subscribed to as per NCTE norms.

6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University/ State Government as the case may be.

- 7. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government as the case may be till such time NCTE regulations in respect of fee structure come into force.
- 8. Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body as the case may be.
- 9. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- 10. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- 11. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If **District Institute of Education & Training, Attingal – 695101, Thiruvananthapuram District, Kerala** contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
