In terms of Section 15(1) of the NCTE Act, 1993 **DISTRICT INSTITUTE OF EDUCATION AND TRAINING, KARVETINAGAR, CHITTOOR DT. - 517 582, ANDHRA PRADESH** had submitted an application to the Southern Regional Committee of NCTE for accord of recognition for the Additional Intake of 30 students in the Tamil medium section in the existing D.Ed. course of 80 students (Telugu medium) of Two years duration from the academic session 2003-04 i.e., with an annual intake of 110 students.

 - iii) The institution has selected the Principal / Head and **12** teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to DISTRICT INSTITUTE OF EDUCATION AND TRAINING, KARVETINAGAR, CHITTOOR DT. - 517 582, ANDHRA PRADESH for D.Ed. Course of Two years from the academic session 2003-2004 for an additional intake of 30 students in the Tamil medium with an annual intake of <u>110</u> students subject to fulfillment of the following :
 - a) The institution will ensure that **Principal and 12** faculty members are in position for an intake of <u>110</u> students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
- 3. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
