## **ORDER**

WHEREAS, **Dr.** Nagarathinam's **Teacher Training Institute**, **No.** 52/7, **Seelanaickanpatti Village**, **Salem-636201**, **Tamilnadu** had submitted an application for D.T.Ed Course on 28.12.2005 and D.T.Ed-Al Course on 16.03.2007. The institution was granted recognition for D.T.Ed course on 08.11.2006 with an annual intake of 50 students and D.T.Ed-Al course on 06.12.2007 thus making an annual intake of 100 students, which includes the existing intake of 50 students and additional intake of 50 students, with the condition to shift to own premises within 3 years.

AND WHEREAS, the institution vide its letter dtd.15.02.2010 had submitted DD bearing no. 632537 dtd.29.01.2010 for Rs.40,000/- towards shifting inspection fee. The inspection of the institution was conducted on 03.06.2011.

AND WHEREAS, the DTERT complaint was received vide letter dated 25.07.2011 stating that appropriate action may be taken to withdraw the recognition granted to the above institution.

AND WHEREAS, the SRC in its 209<sup>th</sup> meeting held on 31<sup>st</sup> July 2011 considered the DTERT complaint dt.25.07.2011 and all the relevant documentary evidences and decided to serve Show Cause Notice under Section 17 of NCTE Act. Accordingly, Show Cause Notice was issued to the institution on 30.09.2011. The institution had submitted its written representation on 31.10.2011.

AND WHEREAS, the SRC in its 213<sup>th</sup> meeting held on 06-07 November, 2011 considered the VT Report, and all the relevant documentary evidences and decided to serve Show Cause Notice under Section 17 of NCTE Act. Accordingly, a Show Cause Notice was issued to the institution on 19.12.2011. The institution had submitted its written representation on 09.01.2012.

AND WHEREAS, the SRC in its 217<sup>th</sup> meeting held on 08<sup>th</sup>-09<sup>th</sup> February, 2012 considered the reply of the institution dt.09.01.2102, VT Report, VCD and all the relevant documentary evidences and decided to serve Final Show Cause Notice under Section 17 of NCTE Act.

AND WHEREAS, accordingly, a Final Show cause notice was issued to the institution on 08.03.2012. The institution had submitted its written representation on 30.03.2012.

AND WHEREAS, the SRC in its 229<sup>th</sup> meeting held on 30-31 July 2012, considered the reply of the institution dt.30.03.2012 and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting of <u>D.T.Ed course only</u> to new premises under intimation to the Affiliating body.

NOW THEREFORE, permission is hereby accorded by SRC to Dr. Nagarathinam's Teacher Training Institute, No. 52/7, Seelanaickanpatti Village, Salem-636201, Tamilnadu to shift its premises to the new location / building at Dr. Nagarathinam's, 31/1B Ananthagoundampalyam Village, Minnakal Post, Rasipuram Taluk, Namakkal District-637505, Tamilnadu.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
