ORDER

WHEREAS, Dr. Nagarathinam's College of Education, No.52/7, Seelanaickanpatti Village, Salem - 636201, Tamilnaduhad submitted an application for B.Ed Course on 28.12.2005. The inspection of the institution was carried out on 10.10.2006. Recognition order was issued to the institution on 08.11.2006 with an annual intake of 100 students, with the condition to shift to own premises within 3 years.

AND WHEREAS, the institution has submitted DD of Rs.40,000/- dated 10.02.2010 shifting inspection has been conducted on 03.06.2011.

AND WHEREAS, the SRC in its 201st meeting held on 22-23 February, 2011 considered the matter along with other relevant documents and decided to process the application as there is no change in the District and College is located at Namakkal whereas only the administrative office is located at Salem.

AND WHEREAS, the SRC in its 204th meeting held on 27-28 April, 2011 considered the VT report and letter of the institution and decided to cause inspection of the institution in the permanent premises in Namakkal District (carved out of erstwhile Salem District), and as the institution had indicated that the above land/location for establishing its permanent premises, even at the time of original application. The inspection of the institution was conducted on 03.06.2011.

AND WHEREAS, the SRC in its 213th meeting held on 6-7 November, 2011 considered the VT Report, and all the relevant documentary evidences and decided to serve Show cause Notice under section 17 of NCTE Act. Accordingly, a Show cause notice was issued to the institution on 19.12.2011. The institution had submitted its written representation on 09.01.2012.

AND WHEREAS, the SRC in its 217th meeting held on 8-9 February 2012 considered the reply of the institution dated 09.01.2102, VT Report, VCD and all the relevant documentary evidences and it was decided to serve Final Show cause Notice under Section 17 of NCTE Act.

AND WHEREAS, accordingly, final show cause notice was issued to the institution on 08.03.2012.

AND WHEREAS, the institution has submitted its willingness affidavit for adherence to NCTE Regulations 2014 on 31.01.2015. Accordingly, revised recognition order was issued to the institution on 27.05.2015 with a condition that the institution has not replied to the show cause notice dated 08.03.2012.

AND WHEREAS, the institution has submitted its written representation on 23.07.2015 along with a photocopy of submission of show cause notice reply dated 29.03.2012 received by SRC on 30.03.2012.

AND WHEREAS, the SRC in its 292nd Meeting held on 29th & 30th September, 2015 considered the matter, written representation on 23.07.2015 from the institution, decided and advised Southern Regional Office as under:

- 1. Permit shifting.
- 2. Ask them to ensure full compliance of the new norms /standards under 2014 Regulations by 30.10.2015

WHEREAS, recognition was granted to Dr.Nagarathinam's College of Education, No.52/7, Seelanaickanpatti Village, Salem-636201, Tamil Nadu for B.Ed course with an annual intake of 100 students, vide this office order No F.SRO/NCTE/B.Ed/2006-2007/8993 dated 08.11.2006.

AND WHEREAS, on the basis of the affidavit submitted by them on 31.01.2015, a revised Recognition Order was issued vide No.F.SRO/NCTE/APS04882/B.Ed/TN/2015-16/65693 dated 27.05.2015.

AND WHEREAS, the institution submitted written representation on 22.10.2016 requesting therein for reduction of strength from 2 units to 1 unit in its B.Ed course.

AND WHEREAS, the request was placed before SRC in its 343rd meeting held on 1st to 2nd August, 2017 and the Committee considered the matter and decided as under-

1. The request for reduction from 2 units to 1 unit is accepted subject to the following conditions:

The request for reduction of intake strength from 2 units to 1 unit is accepted subject to the following conditions:

- (i) The reduction will be w.e.f. 2017-18. The students admitted into the 2 units in 2016-17 will however be entitled to continue with and complete their 2nd year course in 2017-18.
- (ii) Admissions in 2017-18 will be limited to one unit of 50. The affiliating Universities will please ensure that this is strictly observed.
- (iii) Notwithstanding the restriction of admission in the first year course to 50, there will be no reduction in the faculty strength of 1+15, as prescribed in the 2014 Regulations because of the continuing workload in the 2nd year course. The affiliating Universities will please ensure that this is strictly
- (iv) The faculty strength can be reduced to 1+9 w.e.f. 2018-19.

This arrangement will come into force with immediate effect because of the urgency of admissions relating to proximity of counseling. But, it will be subject to subsequent production of the under listed documents by the institutions concerned.

- (i) Resolution of the sponsoring society.
- (ii) NOC of the Affiliating University.
- (iii) No Dues Certificate relating to the Teaching faculty.
- (iv) No Dues Certificate relating to the non-Teaching Faculty.
- 2. These cases will be processed for RPRO purposes separately, subsequently.
- 3. Issue order for the reduction of strength accordingly and resubmit for RPRO processing.
