PREAMBLE

Dr. Vellaswamy Nadar Teacher Training Institute, C.C.M.R. Polytechnic College, Kuruvady, Thanjavur-613003, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed course on 3.2.2004.

In obedience to the directions passed by the Hon'ble High Court order in W.P.No. 27930 of 2005 has directed NCTE to cause inspection of the institution. Accordingly, an inspection was carried out on 15.11.2005. the inspection report was placed before SRC in its 105th meeting held during 2-3rd December, 2005.

After considering the application and other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 12.12.2005 to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

The written representation submitted by the institution on 26.12.2005 was considered by the Regional Committee in its 107th meeting held on 27th December, 2005 and decided to reject the proposal. Accordingly, a rejection order was issued to the institution on 23.1.2006.

Aggrieved by the rejection order passed by SRC-NCTE the institution preferred an appeal dated 24.3.2006 to NCTE-Hqrs., New Delhi. Appellate Authority, New Delhi vide their order No. F.No. 89-54/2006-Appeal dated 19.7.2006 has reversed the order appealed against.

Hence the order.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - a. The institution has acquired the land for setting up the teacher education institution.
 - b. The institution has constructed the building for conducting the course on the above mentioned land.

OR

The institution has made arrangements for conducting the course in the rented premises.

- c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs.3.00 lakhs.
- d. The institution has selected the <u>Principal and five</u> teachers for the said
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Dr. Vellaswamy Nadar Teacher Training Institute, Vellaswamy Nadar Nagar, Thittai Road, Manakarambai, Ramapuram Post, Thanjavur-613003,Tamilnadu for Elementary (D:Ed/D.T.Ed.) course of two years duration from the academic session 2006-2007 with an annual intake of 50 students subject to fulfillment of the following.
 - a. The institution will ensure that <u>Principal and Five</u> faculty members duly approved by DSERT are in position for an intake of <u>50</u> students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
 - b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.

- The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of State Educational Research and Training (DSERT) to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
