WHEREAS, in terms of Section 14(1) of the NCTE Act Vaibhav Educational Society, Plot No. 203, Alankar Plaza, Park Road, Kurnool Village and Post Office, Kurnool Taluk and City, Kurnool District-518001, Andhra Pradesh had submitted an on-line application to the Southern Regional Committee of NCTE on 25.05.2015 and submitted printouts on 29.05.2015 for grant of recognition for B.Ed Programme of two units of 100 Students at Dr.K.V.Subba Reddy D.Ed College Plot /Khasra no. 62/2, Dupadu Village, Lakshmipuram Post Office, Kallur Taluk, Kurnool District -518218, Andhra Pradesh.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section14(3) (a) of the of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to Jr.K.V.Subba Reddy D.Ed College Plot /Khasra no. 62/2, Dupadu Village, Lakshmipuram Post Office, Kallur Taluk, Kurnool District -518218, Andhra Pradesh for conducting B.Ed programme of two years duration with two units of 50 students each from the academic sessions 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDR's shall not be done.

- The institutions shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter –alia, the details of the institution, its location, name of the programme applied for with intake; availability of physical infrastructure, such as Ind, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned.
