Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Dr. B.R.Ambedkar Open University, Prof.G.Ram Reddy Marg, No.46, Jubilee Hills, Hyderabad-500033, Andhra Pradesh for conducting Secondary(B.Ed- Distance Education) course in Telugu Medium of two years duration with an annual intake of 500 (Five Hundred) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:

- i) The University shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ii) The University will ensure that the core faculty at the Headquarters level with one Professor, one Reader and four Lecturers are in position for an intake of 500 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately



5. The University shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The University shall maintain & update the Web-site as per provisions of NCTE Regulations.
7. If the University contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


